1. Enw'r Gorchymyn hwn yw Gorchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd Morgannwg (Diddymu) 2008 a daw i rym ar 1 Ebrill 2008.

**Diddymu Ymddiriedolaeth GIG**

2. Diddymir drwy hyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd Morgannwg a sefydlwyd gan Orchymyn Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Gogledd Morgannwg (Sefydlu) 1996(3), ac yn unol â hynny dirymir y Gorchymyn hwnnw.

The Welsh Ministers in exercise of powers conferred by section 204(1) and paragraph 28(1) of Schedule 3 to the National Health Service (Wales) Act 2006(1) and after completion of the consultation prescribed under paragraph 28(3) of Schedule 3 to that Act(2) hereby make the following Order:

**Title and Commencement**

1. The Title of this Order is the North Glamorgan National Health Service Trust (Dissolution) Order 2008 and it comes into force on 1 April 2008.

**Dissolution of NHS Trust**

2. The North Glamorgan National Health Service Trust established by the North Glamorgan National Health Service Trust (Establishment) Order 1996(3) is hereby dissolved, and accordingly that Order is hereby revoked.
