EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) (Rhif 2) 2008 ("Rheoliadau 2008"). Diwygiodd Rheoliadau 2008 ymhellach Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) 2006 ("Rheoliadau 2006") er mwyn cynyddu'r ffi sy'n daladwy gan ymgymerwyr am arolygiadau o'u gwaith gan awdurdodau stryd yng Nghymru o dan reoliad 3 o Reoliadau 2006.

These Regulations amend the Street Works (Inspection Fees) (Wales) (Amendment) (No. 2) Regulations 2008 ("the 2008 Regulations"). The 2008 Regulations further amended the Street Works (Inspection Fees) (Wales) Regulations 2006 ("the 2006 Regulations") so as to increase the fee payable by undertakers for inspections of their work by street authorities in Wales, under regulation 3 of the 2006 Regulations.

Y ffi a ragnodwyd yn wreiddiol yn Rheoliadau 2006 oedd £21. Newidiwyd y ffi i £24 yng Ngorffennaf 2007 gan Reoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) 2007 (O.S. 2007 Rhif 1713 (Cy.150)), ac fe'i cynyddwyd i £25 gan Reoliadau 2008. Cynyddir y ffi ymhellach yn awr i £50.

The fee originally prescribed in the 2006 Regulations was £21. The fee was altered to £24 in July 2007 by the Street Works (Inspection Fees) (Wales) (Amendment) Regulations 2007 (S.I. 2007 No.1713 (W.150)), and was increased to £25 by the 2008 Regulations. The fee is now further increased to £50.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 75 a 104(1) o Ddeddf Ffyrdd Newydd a Gwaith Stryd 1991(1), ac a freiniwyd bellach ynddynt hwy(2), yn gwneud y Rheoliadau a ganlyn:

The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 75 and 104(1) of the New Roads and Street Works Act 1991(1), and now vested in them(2), make the following regulations:

Enwi, cychwyn a chymhwyso

1. Enw'r Rheoliadau hyn yw Rheoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) 2009. Deuant i rym ar 1 Ebrill 2009 ac maent yn gymwys o ran Cymru.

Title, commencement and application

1. The title of these Regulations is the Street Works (Inspection Fees) (Wales) (Amendment) Regulations 2009. They come into force on 1 April 2009 and apply in relation to Wales.

2. Diwygir ymhellach Reoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) 2006, a ddiwygiwyd eisoes(3) yn unol â rheoliad 3.

**Amendment to the Street Works (Inspection Fees)
(Wales) Regulations 2006**

2. The Street Works (Inspection Fees) (Wales) Regulations 2006, as amended(3) are further amended in accordance with regulation 3.

(2) Cafodd swyddogaethau'r Ysgrifennydd Gwladol o dan adrannau 75 a 104(1) eu trosglwyddo, i'r graddau y maent yn arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672), erthygl 2 ac Atodlen 1. Amnewidiwyd adran 75 yn rhagolygol gan adran 58(2) o Ddeddf Rheoli Traffig 2004 (p.18). Cafodd swyddogaethau Cynulliad Cenedlaethol Cymru o dan yr adrannau 75 a 104(1) dywededig eu trosglwyddo i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006.

(3) O.S. 2006/1532 (Cy.150). Cafodd y Rheoliadau hyn eu diwygio gan Reoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) 2007 (O.S. 2007/1713) (Cy.150) a chan Reoliadau Gwaith Stryd (Ffioedd Arolygu) (Cymru) (Diwygio) (Rhif 2) 2008 (O.S. 2008/1213 (Cy. 121)).

(2) The functions of the Secretary of State under sections 75 and 104(1) were transferred, so far as exercisable in relation to Wales, to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672), article 2 and Schedule 1. Section 75 is prospectively substituted by section 58(2) of the Traffic Management Act 2004 (c.18). The functions of the National Assembly for Wales under the said sections 75 and 104(1) were transferred to the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006.

(3) S.I. 2006/1532 (W.150). These Regulations have previously been amended by the Street Works (Inspection Fees) (Wales) (Amendment) Regulations 2007 (S.I. 2007/1713 (W.150) and by the Street Works (Inspection Fees) (Wales) (Amendment) (No. 2) Regulations 2008 (S.I. 2008/1213 (W.121)).
