Mae'r Rheoliadau hyn yn disodli Atodlen 1 i Reoliadau Cynhyrchion sy'n Dod o Anifeiliaid (Mewnforion Trydydd Gwledydd) (Cymru) 2007. Mae'r Atodlen newydd yn ymgorffori nifer o ddarnau newydd a darnau diwygiedig o ddeddfwriaeth Gymunedol sydd wedi dod i rym ers i'r Rheoliadau hynny ddod i rym.

These Regulations replace Schedule 1 to the Products of Animal Origin (Third Country Imports) (Wales) Regulations 2007. The new Schedule incorporates a number of new and amended pieces of Community legislation that have come into force since those Regulations came into force.

Mae'r Atodlen newydd yn darparu bod y darpariaethau yn Atodlen 1 bellach yn rhai y gellir eu newid.

The new Schedule provides that the provisions in Schedule 1 are now ambulatory.

Nid oes Asesiad Effaith Rheoleiddiol wedi'i lunio ar gyfer yr offeryn hwn, gan na ragwelir y bydd yr offeryn yn effeithio o gwbl ar fusnes, elusennau na chyrrff gwirfoddol.

The Welsh Ministers are designated(1) for the purposes of making Regulations under section 2(2) of the European Communities Act 1972(2) in relation to the common agricultural policy of the European Community.

These Regulations make provision for a purpose mentioned in that section and it appears to the Welsh Ministers that it is expedient for the references to the legislation set out in the Schedule to be construed as references to that legislation as amended from time to time.

The Welsh Ministers make these Regulations in exercise of the powers conferred by that section.

**Title, application and commencement**

1. The title of these Regulations is the Products of Animal Origin (Third Country Imports) (Wales) (Amendment) Regulations 2009, they apply in relation to Wales and come into force on 20 March 2009.
