Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Trefniadau Pryderon, Cwynion ac Iawn) (Cymru) 2011 ("y prif Reoliadau").

These Regulations amend the National Health Service (Concerns, Complaints and Redress Arrangements) (Wales) Regulations 2011 ("the principal Regulations").

Mae rheoliad 2(1) yn gohirio'r dyddiad y daw Rhan 7 o'r prif Reoliadau i rym, o 1 Hydref 2011 tan 1 Ebrill 2012. Mae Rhan 7 o'r prif Reoliadau yn ymdrin â'r modd y mae iawn i'w ddarparu pan fo Ymddiriedolaeth GIG yng Nghymru neu Fwrdd Iechyd Lleol yng Nghymru yn ymuno mewn trefniant i ddarparu gwasanaethau iechyd gyda chorff GIG yn Lloegr, yr Alban neu Ogledd Iwerddon.

Regulation 2(1) delays the coming into force of Part 7 of the principal Regulations from 1 October 2011 to 1 April 2012. Part 7 of the principal Regulations deals with how redress is to be provided where an NHS Trust in Wales or a Local Health Board in Wales enters into an arrangement for the provision of health services with an NHS body in England, Scotland or Northern Ireland.

Mae rheoliad 2(2) yn amnewid rheoliad 52(5) newydd yn y prif Reoliadau, i adlewyrchu'r dyddiad newydd y daw Rhan 7 i rym a chymhwyso'r trefniadau iawn trawsffiniol yn y Rhan honno i wasanaethau sydd wedi eu darparu ar neu ar ôl 1 Ebrill 2012.

Regulation 2(2) substitutes a new regulation 52(5) into the principal Regulations to reflect the new coming into force date of Part 7 and to apply the cross border redress arrangements in that Part to services that have been provided on or after 1 April 2012.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ni thybiwyd bod angen cynnal aseidiad effaith rheoleiddiol o gostau a buddion tebygol cydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddir gan adrannau 1, 11(2)(d) ac 11(3) o Fesur Gwneud Iawn am Gamweddau'r GIG (Cymru) 2008(1).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 1, 11(2)(d) and 11(3) of the NHS Redress (Wales) Measure 2008(1).

Title, commencement, application and interpretation

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Trefniadau Pryderon, Cwynion ac Iawn) (Cymru) (Diwygio) 2011, a deuant i rym ar 3 Awst 2011.

1.—(1) The title of these Regulations is the National Health Service (Concerns, Complaints and Redress Arrangements) (Wales) (Amendment) Regulations 2011 and they come into force on 3 August 2011.

(2) Mae'r Rheoliadau hyn yn gymwys i wasanaethau a ddarperir fel rhan o'r gwasanaeth iechyd yng Nghymru.

(2) These Regulations apply to services provided as part of the health service in Wales.

(3) Yn y Rheoliadau hyn, ystyr "y prif Reoliadau" (*"the principal Regulations"*) yw Rheoliadau'r Gwasanaeth Iechyd Gwladol (Trefniadau Pryderon, Cwynion ac Iawn) (Cymru) 2011(2).

(3) In these Regulations "the principal Regulations" (*"y prif Reoliadau"*) means the National Health Service (Concerns, Complaints and Redress Arrangements) (Wales) Regulations 2011(2).

Diwygio'r prif Reoliadau

Amendment of the principal Regulations

2.—(1) Yn rheoliad 1(2) yn lle "1 Hydref 2011" rhodder "1 Ebrill 2012".

2.—(1) In regulation 1(2) for "1 October 2011" substitute "1 April 2012".

(2) Yn lle rheoliad 52(5) rhodder: "Ni fydd cwynion ynghylch gwasanaethau a ddarparwyd gan gyrff GIG Lloegr, cyrff GIG yr Alban neu gyrff GIG Gogledd Iwerddon, fel y'u diffinnir yn rheoliad 34, cyn 1 Ebrill 2012 yn cael eu hystyried o dan Ran 7 o'r Rheoliadau hyn."

(2) For regulation 52(5) substitute: "Complaints about services provided by English NHS bodies, Scottish NHS bodies or Northern Irish NHS bodies, as defined in regulation 34, before 1 April 2012 will not be considered under Part 7 of these Regulations."
