The Welsh Ministers, in exercise of the powers conferred upon them by section 21(1) of the Waste (Wales) Measure 2010(1), make the following Order:

Title, application and interpretation

1.–(1) The title of this Order is the Waste (Wales) Measure 2010 (Commencement) Order 2011.

(2) This Order applies in relation to Wales.

(3) In this Order–

"the Measure" ("*y Mesur*") means the Waste (Wales) Measure 2010.
