Mae erthygl 3(2) o'r Gorchymyn hwn yn diwygio erthyglau 4, 5(1), 6(1), 7, 8(1) a 9(1) o Orchymyn 2011 drwy ddileu'r cyfeiriadau at y Refferendwm Pleidlais Amgen. Fel y'i diwygiwyd, mae erthygl 4 o Orchymyn 2011 yn pennu mai'r cyfanswm cyffredinol mwyaf y mae modd ei adennill ar gyfer etholiad etholaeth Cynulliad a ymleddir yw'r hyn a ddangosir yng ngholofn 4 o'r tabl yn Atodlen 1. EXPLANATORY NOTE

(This note is not part of the Order)

This Order provides for payments for services and expenses of returning officers in connection with the conduct of National Assembly for Wales elections.

This Order amends The National Assembly for Wales (Returning Officers' Charges) Order 2011 (S.I. 2011/632) (W.92) ("the 2011 Order"). This Order is made under article 23 of the National Assembly for Wales (Representation of the People) Order 2007 (S.I. 2007/236). Article 23 provides that a constituency or a regional returning officer is entitled to recover charges in respect of services rendered or expenses incurred in connection with an Assembly election.

Article 3(2) of this Order amends articles 4, 5(1), 6(1), 7, 8(1) and 9(1) of the 2011 Order by removing references to the Alternative Vote Referendum. As amended, article 4 of the 2011 Order specifies the overall maximum recoverable amount for a contested Assembly constituency election as shown in column 4 of the table in Schedule 1. As amended, article 5 of the 2011 Order specifies the maximum recoverable amount for services at a contested Assembly constituency election as shown in column 2 of the table in Schedule 1. As amended, article 6 of the 2011 Order specifies the maximum recoverable amount for expenses at a contested Assembly constituency election as shown in column 3 of the table in Schedule 1. As amended, article 7 of the 2011 Order specifies the

(Mae erthygl 3(2) hefyd yn dileu'r cyfeiriadau at y Refferendwm Pleidlais Amgen o benawdau erthyglau 5, 6, 8 a 9 o Orchymyn 2011 ac Atodlen 2 iddo).

Mae erthygl 3(3) yn amnewid Atodlen 1 i Orchymyn 2011. Mae'r tabl yn Atodlen 1 sydd wedi'i hamnewid yn disgrifio'r cyfanswm cyffredinol mwyaf a'r cyfansymiau mwyaf am wasanaethau ac am dreuliau y caiff swyddog canlyniadau etholaeth eu hadennill ar gyfer etholiad i Gynulliad Cenedlaethol Cymru a ymleddir neu mewn cysylltiad ag etholiad o'r fath.

overall maximum recoverable amount for a contested Assembly regional election as shown in column 4 of the table in Schedule 2. As amended, article 8 of the 2011 Order specifies the maximum recoverable amount for services at a contested Assembly regional election as shown in column 2 of the table in Schedule 2 and article 9, as amended, specifies the maximum recoverable amount for expenses at a contested Assembly regional election as shown in column 3 of the table in Schedule 2. (Article 3(2) also removes references to the Alternative Vote Referendum from the headings to articles 5, 6, 8 and 9 of, and Schedule 2 to, the 2011 Order).

Article 3(3) substitutes Schedule 1 to the 2011 Order. The table contained at substituted Schedule 1 describes the overall maximum recoverable amount and the maximum recoverable amounts for services and expenses by a constituency returning officer for, or in connection with, a contested election to the National Assembly for Wales.

The Welsh Ministers, in exercise of the powers conferred on the National Assembly for Wales by article 23 of the National Assembly for Wales (Representation of the People) Order 2007(1) and now vested in them(2), make the following Order—

Title, application and commencement

1.—(1) The title of this Order is the National Assembly for Wales (Returning Officers' Charges) (Amendment) Order 2012.

(2) This Order comes into force on 1 October 2012.

(3) This Order applies in relation to Wales.

Interpretation

2. In this Order—

- (a) "Assembly constituency" ("etholaeth Cynulliad") is to be construed in accordance with section 2 of the Government of Wales Act 2006;
- (b) "Assembly electoral region" ("rhanbarth etholiadol Cynulliad") is to be construed in accordance with section 2 of the Government of Wales Act 2006.

(2) Yn rhinwedd adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi trosglwyddwyd pwerau Cynulliad Cenedlaethol Cymru i Weinidogion Cymru.

(2) By virtue of section 162 of, and paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c.32) the powers of the National Assembly for Wales were transferred to the Welsh Ministers.

3.—(1) Mae Gorchymyn Cynulliad Cenedlaethol Cymru (Taliadau Swyddogion Canlyniadau) (Cymru) 2011 wedi ei ddiwygio fel a ganlyn.

(2) Yn erthyglau 4, 5(1), 6(1), 7, 8(1) a 9(1) ac ym mhenawdau erthyglau 5, 6, 8 a 9 ac Atodlen 2, hepgorer y geiriau "ac a gynhelir ar yr un diwrnod â'r Refferendwm Pleidlais Amgen".

(3) Yn lle Atodlen 1, rhodder yr Atodlen a ganlyn—

**Amendments to the National Assembly for Wales
(Returning Officers' Charges) Order 2011**

3.—(1) The National Assembly for Wales (Returning Officers' Charges) (Wales) Order 2011 is amended as follows.

(2) In articles 4, 5(1), 6(1), 7, 8(1) and 9(1) and in the headings to articles 5, 6, 8 and 9 and Schedule 2, omit the words "held on the same day as the Alternative Vote Referendum".

(3) For Schedule 1, substitute the following Schedule—
