The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau – South of Birkenhead Trunk Road (A494) (“the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted because of the likelihood of danger to the public.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984<sup>(1)</sup> and of all other enabling powers<sup>(2)</sup>, make this Order.

**Title, Interpretation and Commencement**

1. This Order comes into force on 11 June 2015. Its title is The A494 Trunk Road (Ysgol O. M. Edwards, Llanuwchllyn, Gwynedd) (Temporary Part-time 20mph Speed Limit) Order 2015.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the trunk road at Llanuwchllyn in the County of Gwynedd that extends from a point 110 metres south of the centre-point of its junction with the B4403 to a point 150 metres north of the said junction.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Restriction**

3. Subject to the provisions of article 5, no person shall drive or cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour in the length of the trunk road.

### **Suspension**

4. The provisions of The A494 Trunk Road (Llanuwchllyn, Bala) (40 MPH Speed Limit) Order 2003(3) insofar as they apply to the length of the trunk road specified in article 2, are hereby suspended during such times as the restriction specified in article 3 is in operation.

### **Application**

5. The provisions of article 3 apply only during such times and to such extent as the application of the restriction referred to therein is indicated by activated traffic signs.

### **Duration of this Order**

6. The maximum duration for this Order shall be 18 months.
