**The A479 Trunk Road (Tretower to
Cwmdu and Cwmdu to Lower
Genffordd, Powys) (Temporary 50
MPH Speed Limit) Order 2015**

Made 26 January 2015

Coming into force 1 February 2015

The Welsh Ministers, being the traffic authority for the relevant lengths of the Glanusk Park – Llyswen Trunk Road (A479) (“the trunk road”), are satisfied that traffic in specified lengths of the trunk road should be restricted by reason of the likelihood of danger to the public.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984⁽¹⁾ and of all other enabling powers⁽²⁾, make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 1 February 2015 and its title is The A479 Trunk Road (Tretower to Cwmdu and Cwmdu to Lower Genffordd, Powys) (Temporary 50 MPH Speed Limit) Order 2015.

2. (1) In this Order:

“the lengths of the trunk road” (“*y darnau o’r gefnffordd*”) means those lengths of the trunk road in County of Powys specified in the Schedule to this Order;

“restriction period” (“*cyfnod y cyfyngiad*”) means the period commencing at 00:01 hours on 1 February 2015 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restriction

3. Subject to the provisions of article 4, no person shall, during the restriction period, drive or cause or permit any vehicle to proceed at a speed exceeding 50 miles per hour in the lengths of the trunk road specified in the Schedule.

Application

4. The provisions of article 3 apply only during such times and to such extent as the application of the restriction referred to therein is indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order shall be 18 months.

- (1) 1984 c.27; Section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.
- (2) By virtue of S.I. 1999/672, article 2 and Schedule 1, and paragraph 30 of Schedule 11 to the Government of Wales Act 2006, these powers are now exercisable by the Welsh Ministers in relation to Wales.

SCHEDULE

- i) That length of the trunk road which extends from a point 65 metres north-west of its junction with the U0496, Tretower, in a northerly direction to a point 18 metres south of its junction with the U0504, Cwmdu.
- ii) That length of the trunk road which extends from a point 25 metres south-west of its junction with the U0170, Cwmdu, in a northerly direction to a point 165 metres east of its junction with the C0087, Lower Genffordd.
