Mae'r Rheoliadau hyn yn diwygio—

- (a) Rheoliadau Arolygu Addysg a Hyfforddiant (Cymru) 2001,
- (b) Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 2006,
- (c) Rheoliadau Arolygu'r Gwasanaeth Gyrfaoedd a Gwasanaethau Cysylltiedig (Cymru) 2006, a
- (d) Rheoliadau Addysg (Arolygu Addysg Feithrin) (Cymru) 2015,

er mwyn ei gwneud yn ofynnol i Brif Arolygydd Ei Mawrhydi dros Addysg a Hyfforddiant yng Nghymru/Her Majesty's Chief Inspector of Education and Training in Wales arolygu o leiaf unwaith o fewn cyfnod o saith mlynedd yn dechrau ar 1 Medi 2016 ac yn dod i ben ar 31 Awst 2023 ac o leiaf unwaith o fewn pob cyfnod o chwe blynedd wedi hynny (rheoliadau 2, 3 a 4).

Mae'r Rheoliadau hyn hefyd yn cywiro rheoliad 3(2)(f) o Reoliadau Addysg (Arolygu Addysg Feithrin) (Cymru) 2015 ("Rheoliadau 2015"). Mae rheoliad 3(2)(f) o Reoliadau 2015 yn cyfeirio at swyddogaethau cofrestru awdurdodau lleol yn adrannau 20 a 22 o Fesur Plant a Theuluoedd (Cymru) 2010 ("Mesur 2010"). Mae rheoliad 4 o'r Rheoliadau hyn yn diwygio'r cyfeiriad hwnnw er mwyn iddo gyfeirio at swyddogaethau cofrestru Gweinidogion Cymru yn adrannau 20 neu 22 o Fesur 2010.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the—

- (a) Inspection of Education and Training (Wales) Regulations 2001,
- (b) Education (School Inspection) (Wales) Regulations 2006,
- (c) Inspection of Careers and Related Services (Wales) Regulations 2006, and
- (d) Education (Inspection of Nursery Education) (Wales) Regulations 2015,

so as to require Her Majesty's Chief Inspector of Education and Training in Wales/Prif Arolygydd Ei Mawrhydi dros Addysg a Hyfforddiant yng Nghymru to inspect at least once within a seven year period beginning on 1 September 2016 and ending on 31 August 2023 and at least once within every subsequent six year period (regulations 2, 3 and 4).

These Regulations also correct regulation 3(2)(f) of the Education (Inspection of Nursery Regulations) (Wales) Regulations 2015 ("the 2015 Regulations"). Regulation 3(2)(f) of the 2015 Regulations refers to the local authorities registration functions in sections 20 and 22 of the Children and Families (Wales) Measure 2010 ("the 2010 Measure"). Regulation 4 of these Regulations amends that reference so that it refers to the Welsh Ministers registration functions in sections 20 or 22 of the 2010 Measure.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oed yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

2. Yn rheoliad 2 o Reoliadau Arolygu Addysg a Hyfforddiant (Cymru) 2001(1), yn lle paragraff (1)(b) rhodder—

“(b) ym mhob achos arall, o leiaf unwaith o fewn cyfnod o saith mlynedd yn dechrau ar 1 Medi 2016 ac yn dod i ben ar 31 Awst 2023 ac o leiaf unwaith o fewn pob cyfnod o chwe blynedd wedi hynny yn dechrau pan ddaw'r cyfnod blaenorol i ben.”

## Diwygio Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 2006

3. Mae Rheoliadau Addysg (Arolygu Ysgolion) (Cymru) 2006(2) wedi eu diwygio fel a ganlyn—

## Title, commencement and application

1.—(1) The title of these Regulations is the Education (Amendments Relating to the Intervals for Inspection of Education and Training) (Wales) Regulations 2016 and they come into force on 1 September 2016.

(2) These Regulations apply in relation to Wales.

## Amendment to the Inspection of Education and Training (Wales) Regulations 2001

2. In regulation 2 of the Inspection of Education and Training (Wales) Regulations 2001(1), for paragraph (1)(b) substitute—

“(b) in all other cases, at least once within a seven year period beginning on 1 September 2016 and ending on 31 August 2023 and at least once within every subsequent six year period beginning on the expiry of the previous period.”

## Amendments to the Education (School Inspection) (Wales) Regulations 2006

3. The Education (School Inspection) (Wales) Regulations 2006(2) are amended as follows—

(a) in regulation 6, for paragraph (1)(b), substitute—

“(b) in all other cases, at least once within a seven year period beginning on 1 September 2016 and ending on 31 August 2023 and at least once within every subsequent six year period beginning on the expiry of the previous period.”; and

- (b) yn rheoliad 4, yn lle paragraff (1)(b), rhodder—

“(b) in all other cases, at least once within a seven year period beginning on 1 September 2016 and ending on 31 August 2023 and at least once within every subsequent six year period beginning on the expiry of the previous period.”

#### **Amendment to the Inspection of the Careers and Related Services (Wales) Regulations 2006**

4. In regulation 4 of the Inspection of the Careers and Related Services (Wales) Regulations 2006(1), for paragraph (1) substitute—

“(1) Save where regulation 3 applies, the Chief Inspector must inspect each service provider under section 55 of the 2005 Act and each relevant provider under section 56 of the 2005 Act at least once within a seven year period beginning on 1 September 2016 and ending on 31 August 2023 and at least once within every subsequent six year period beginning on the expiry of the previous period.”

#### **Amendment to the Education (Inspection of Nursery Education) (Wales) Regulations 2015**

5. The Education (Inspection of Nursery Education) (Wales) Regulations 2015(2) are amended as follows—

- (a) in regulation 3, for paragraph (2)(f) substitute—
- “(f) in the case of nursery education provided by a person registered by the Welsh Ministers under sections 20 or 22 of the Children and Families (Wales) Measure 2010(3), that person and the Welsh Ministers”; and
- (b) in regulation 4, for paragraph (1)(b), substitute—
