Mae'r Gorchymyn hwn wedi ei wneud o dan adran 22 o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006 ("y Ddeddf"). Mae'n sefydlu Awdurdod Iechyd Arbennig newydd, sef Addysg a Gwella Iechyd Cymru ("AaGIC"), ac yn gwneud darpariaeth ynghylch ei swyddogaethau a'i gyfansoddiad.

Mae erthygl 3 yn nodi prif swyddogaethau AaGIC sydd i gael eu pennu'n fwy penodol mewn cyfarwyddydau a roddir gan Weinidogion Cymru o dan adran 24 o'r Ddeddf. Mae prif swyddogaethau AaGIC yn ymwneud â chynllunio, comisiynu a chflenwi addysg a hyfforddiant ar gyfer personau sy'n gyflogedig, neu sy'n ystyried dod yn gyflogedig, mewn gweithgaredd sy'n ymwneud â'r gwasanaeth iechyd yng Nghymru.

Mae erthygl 4 yn nodi cyfansoddiad AaGIC ac mae erthygl 5 yn darparu bod Deddf Cyrff Cyhoeddus (Mynediad i Gyfarfodydd) 1960 yn gymwys i gyfarfodydd AaGIC.

Nid yw'r Gorchymyn hwn yn gwneud unrhyw ddarpariaeth yn ymwneud â throsglwyddo swyddogion, eiddo na rhwymedigaethau.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. The Health Education and Improvement Wales (Establishment and Constitution) Order 2017

EXPLANATORY NOTE

(*This note is not part of the Order*)

This Order is made under section 22 of the National Health Service (Wales) Act 2006 ("the Act"). It establishes a new Special Health Authority, Health Education and Improvement Wales ("HEIW"), and makes provision about its functions and constitution.

Article 3 sets out HEIW's principal functions which are to be specified more particularly in directions given by the Welsh Ministers under section 24 of the Act. HEIW's principal functions relate to the planning, commissioning and delivery of education and training for persons who are employed, or are considering becoming employed, in an activity relating to the health service in Wales.

Article 4 sets out HEIW's constitution and article 5 provides that the Public Bodies (Admission to Meetings) Act 1960 applies to HEIW's meetings.

This Order makes no provision relating to the transfer of officers, property or liabilities.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with this Order. 3.—(1) Mae AaGIC i arfer—

The Health Education and Improvement Wales (Establishment and Constitution) Order 2017

Made 11 September 2017

Laid before the National Assembly for Wales
13 September 2017

Coming into force 5 October 2017

The Welsh Ministers make the following Order in exercise of the powers conferred by section 22(1), (2), (4)(a) and (c) of the National Health Service (Wales) Act 2006(1).

Title, commencement and interpretation

1.—(1) The title of this Order is the Health Education and Improvement Wales (Establishment and Constitution) Order 2017.

(2) This Order comes into force on 5 October 2017.

(3) In this Order “HEIW” means Health Education and Improvement Wales.

Establishment of HEIW

2. There is established a Special Health Authority known as Health Education and Improvement Wales or Addysg a Gwella Iechyd Cymru.

Functions of HEIW

3.—(1) HEIW is to exercise—

(a) such functions in relation to the planning, commissioning and delivery of education and training for persons who are employed, or who are considering becoming employed, in

(2) Yn yr erthygl hon, ystyr "gwasanaethau iechyd" yw gwasanaethau a ddarperir fel rhan o'r gwasanaeth iechyd a barheir o dan adran 1(1) o Ddeddf y Gwasanaeth Iechyd Gwladol (Cymru) 2006.

Cyfansoddiad AaGIC

4.—(1) Mae gan AaGIC—

- (a) cadeirydd;
- (b) dim mwy na 6 aelod arall nad ydynt yn swyddogion AaGIC yn ychwanegol at y cadeirydd; ac
- (c) dim mwy na 5 aelod arall sy'n swyddogion AaGIC gan gynnwys y person sydd, am y tro, yn dal swydd y prif weithredwr.

(2) Ni chaiff nifer yr aelodau sy'n swyddogion AaGIC fod yn fwy na nifer yr aelodau nad ydynt yn swyddogion o'r fath.

Cyfarfodydd cyhoeddus

5. Mae Deddf Cyrff Cyhoeddus (Mynediad i Gyfarfodydd) 1960(2) i fod yn gymwys i AaGIC.

any activity which involves or is connected with the provision of health services; and

- (b) such other functions;
as the Welsh Ministers may direct(1).

(2) In this article, "health services" means services provided as part of the health service continued under section 1(1) of the National Health Service (Wales) Act 2006.

Constitution of HEIW

4.—(1) HEIW consists of—

- (a) a chairman;
- (b) not more than 6 other members who are not officers of HEIW in addition to the chairman; and
- (c) not more than 5 other members who are officers of HEIW including the person who for the time being holds the office of chief executive.

(2) The number of members who are officers of HEIW must not exceed the number of members who are not such officers.

Public meetings

5. The Public Bodies (Admission to Meetings) Act 1960(2) is to apply to HEIW.
