EXPLANATORY NOTE

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn gwneud diwygiadau amrywiol i is-ddeddfwriaeth ym maes pysgodfeydd môr sy'n ymwneud â Chymru a pharth Cymru.

Mae'r diwygiadau'n rhoi cyfeiriadau at Reoliad (EU) 2019/1241 Senedd Ewrop a'r Cyngor ar gadwraeth adnoddau pysgodfeydd a diogelu ecosystemau'r môr drwy fesurau technegol, sydd wedi diddymu ac wedi disodli Rheoliad y Cyngor (EC) 850/98, yn lle cyfeiriadau at Reoliad y Cyngor (EC) Rhif 850/98 ar gyfer cadwraeth adnoddau pysgodfeydd drwy fesurau technegol er mwyn diogelu pysgod ifanc organebau môr.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

These Regulations make miscellaneous amendments to secondary legislation in the field of sea fisheries that relates to Wales and the Welsh zone.

The amendments replace references to Council Regulation (EC) No 850/98 for the conservation of fishery resources through technical measures for the protection of juveniles of marine organisms with references to Regulation (EU) 2019/1241 of the European Parliament and of the Council on the conservation of fisheries resources and the protection of marine ecosystems through technical measures, which has repealed and replaced Council Regulation (EC) 850/98.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers make these Regulations in exercise of the powers conferred by sections 1(1) and (3), and 5(1) of the Sea Fish (Conservation) Act 1967(1), and now vested in them(2), and paragraph 1A

Those functions were then further transferred to the Welsh Ministers by section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32). So far as exercisable in relation to the Welsh zone, the functions of the Ministers under sections 1(3), (4) and (6), and 5(1) and (2) of the 1967 Act were transferred to the Welsh Ministers by article 4(1)(b) of the Welsh Zone (Boundaries and Transfer of Functions) Order 2010 (S.I. 2010/760).

2. Yng Ngorchymyn Gwahardd Pysgota â Threillrwydi Lluosog (Cymru) 2003(3), yn erthygl 2, yn lle'r diffiniad o “Rheoliad y Cyngor” rhodder—

“ystyr “Rheoliad y Cyngor” (“*the Council Regulation*”) yw Rheoliad (EU) 2019/1241 Senedd Ewrop a'r Cyngor dyddiedig 20 Mehefin 2019 ar gadwraeth adnoddau pysgodfeydd a diogelu ecosystemau'r môr drwy fesurau technegol;”.

Gorchymyn Pysgota am Gregyn Bylchog (Cymru) (Rhif 2) 2010

3. Yng Ngorchymyn Pysgota am Gregyn Bylchog (Cymru) (Rhif 2) 2010(4), yn lle erthygl 11(2) rhodder—

“(2) At ddibenion paragraff (1), mae maint cragen fylchog i'w fesur yn unol â pharagraff 6 o Atodiad 4 i Reoliad (EU) 2019/1241 Senedd

of Schedule 2 to the European Communities Act 1972 (“the 1972 Act”)(1).

The Welsh Ministers are designated for the purposes of the 1972 Act in relation to the common agricultural policy(2).

These Regulations make provision for a purpose mentioned in section 2(2) of the 1972 Act and it appears to the Welsh Ministers that it is expedient for the reference to an EU instrument in regulation 3 to be construed as a reference to that instrument as amended from time to time.

Title and commencement

1.—(1) The title of these Regulations is the Sea Fishing (Miscellaneous Amendments) (Wales) Regulations 2019.

(2) These Regulations come into force on 1 November 2019.

The Prohibition of Fishing with Multiple Trawls (Wales) Order 2003

2. In the Prohibition of Fishing with Multiple Trawls (Wales) Order 2003(3), in article 2, for the definition of “the Council Regulation” substitute—

““the Council Regulation (“*Rheoliad y Cyngor*”) means Regulation (EU) 2019/1241 of the European Parliament and of the Council of 20 June 2019 on the conservation of fisheries resources and the protection of marine ecosystems through technical measures;”.

Scallop Fishing (Wales) (No. 2) Order 2010

3. In the Scallop Fishing (Wales) (No. 2) Order 2010(4), for article 11(2) substitute—

“(2) For the purposes of paragraph (1), the size of a scallop is to be measured in accordance with paragraph 6 of Annex 4 to Regulation (EU) 2019/1241 of the European Parliament and of

4. Yng Ngorchymyn Pysgota am Gregyn Moch (Cymru) 2019(1), yn lle erthygl 6 rhodder—

"6. At ddibenion erthyglau 3, 4 a 5, mae maint cragen foch i'w fesur yn unol â pharagraff 6 o Atodiad 6 i Reoliad (EU) 2019/1241 Senedd Ewrop a'r Cyngor dyddiedig 20 Mehefin 2019 ar gadwraeth adnoddau pysgodfeydd a diogelu ecosystemau'r môr drwy fesurau technegol."

the Council of 20 June 2019 on the conservation of fisheries resources and the protection of marine ecosystems through technical measures as amended from time to time."

Whelk Fishing (Wales) Order 2019

4. In the Whelk Fishing (Wales) Order 2019(1), for article 6 substitute—

"6. For the purposes of articles 3, 4 and 5, the size of a whelk is to be measured in accordance with paragraph 6 of Annex 6 to Regulation (EU) 2019/1241 of the European Parliament and of the Council of 20 June 2019 on the conservation of fisheries resources and the protection of marine ecosystems through technical measures."
