**EXPLANATORY NOTE**

Mae Deddf Iechyd y Cyhoedd (Isafbris am Alcohol) (Cymru) 2018 (“Deddf 2018”) yn gwneud darpariaeth ynghylch yr isafbris y mae alcohol i’w gyflenwi amdano gan fanwerthwyr alcohol o fangreoddedd cymhwysol yng Nghymru i berson yng Nghymru, ac mae’n sefydlu cyfundrefn orfodi a arweinir gan yr awdurdod lleol.

The Public Health (Minimum Price for Alcohol) (Wales) Act 2018 (“the 2018 Act”) makes provision about the minimum price for which alcohol is to be supplied by alcohol retailers from qualifying premises in Wales to a person in Wales and establishes a local authority led enforcement regime.

Mae adran 1 o Ddeddf 2018 yn nodi’r fformiwla sydd i’w chymhwyso wrth gyfrifo’r isafbris cymwys at y diben hwn. Y fformiwla honno yw  $I \times Cr \times Cy$ .

Section 1 of the 2018 Act sets out the formula which is to be applied in calculating the applicable minimum price for this purpose. That formula is  $M \times S \times V$ .

I yw’r isafbris uned a bennir mewn rheoliadau; Cr yw cryfder yr alcohol, a fynegir fel rhif prifol (felly er enghraifft os yw’r cryfder yn 5%, 5 fydd y rhif prifol perthnasol); a Cy yw cyfaint yr alcohol mewn litrau.

M is the minimum unit price which is specified in regulations; S is the strength of the alcohol, expressed as a cardinal number (so for instance if the strength is 5%, the relevant cardinal number will be 5); and V is the volume of the alcohol in litres.

Mae’r Rheoliadau hyn yn pennu mai’r isafbris uned (I) at ddibenion Deddf 2018 yw £0.50.

These Regulations specify that the minimum unit price (M) for the purposes of the 2018 Act is £0.50.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â’r Rheoliadau hyn. O ganlyniad, lluniwyd aseiad effaith rheoleiddiol o’r costau a’r manteision sy’n debygol o ddeillio o gydymffurfio â’r Rheoliadau hyn yng Nghymru. Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir gan adrannau 1(1)(a) a 26 o Ddeddf Iechyd y Cyhoedd (Isafbris am Alcohol) (Cymru) 2018(1), yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers in exercise of the powers conferred by sections 1(1)(a) and 26 of the Public Health (Minimum Price for Alcohol) (Wales) Act 2018(1), make the following Regulations.

Cynhaliwyd ymgynghoriad fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(2).

There has been a consultation as required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying procedures in matters of food safety(2).

Yn unol ag adran 26(2)(a) o Ddeddf Iechyd y Cyhoedd (Isafbris am Alcohol) (Cymru) 2018, gosodwyd drafft o'r offeryn hwn gerbron Cynulliad Cenedlaethol Cymru ac fe'i cymeradwywyd ganddo drwy benderfyniad.

In accordance with section 26(2)(a) of the Public Health (Minimum Price for Alcohol) (Wales) Act 2018, a draft of this instrument has been laid before and approved by resolution of the National Assembly for Wales.

#### **Title and commencement**

**1.**—(1) The title of these Regulations is the Public Health (Minimum Price for Alcohol) (Minimum Unit Price) (Wales) Regulations 2019.

(2) These Regulations come into force on 2 March 2020.
