EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau'r Gwasanaeth Iechyd Gwladol (Contractau Gwasanaethau Meddygol Cyffredinol) (Cymru) 2004, Rheoliadau'r Gwasanaeth Iechyd Gwladol (Presgripsiynau am Ddim a Ffioedd am Gyffuriau a Chyfarpar) (Cymru) 2007 a Rheoliadau'r Gwasanaeth Iechyd Gwladol (Gwasanaethau Fferyllol) (Cymru) 2013 i estyn y diffiniad o ragnodydd i gynnwys parafeddygon-ragnodwyr annibynnol. Maent hefyd yn diwygio'r diffiniad o ragnodydd atodol yn y Rheoliadau hynny i gynnwys parafeddygon-ragnodwyr atodol.

These Regulations amend the National Health Service (General Medical Services Contracts) (Wales) Regulations 2004, the National Health Service (Free Prescriptions and Charges for Drugs and Appliances) (Wales) Regulations 2007 and the National Health Service (Pharmaceutical Services) (Wales) Regulations 2013 to extend the definition of prescriber to include paramedic independent prescribers. They also amend the definition of supplementary prescriber in those Regulations to include paramedic supplementary prescribers.

Mae'r Rheoliadau hyn hefyd yn diwygio Rheoliadau Codi Tâl am Fagiau Siopa Untro (Cymru) 2010 drwy estyn yr esemptiad rhag y gofyniad i godi tâl am fagiau siopa untro i gynnwys cynhyrchion a ragnodir gan barafeddyg-ragnodydd annibynnol a pharafeddyg-ragnodydd atodol.

These Regulations also amend the Single Use Carrier Bags Charge (Wales) Regulations 2010 by extending the exemption from the requirement to charge for single use carrier bags to include products prescribed by a paramedic independent prescriber and a paramedic supplementary prescriber.

Mae'r diwygiadau hyn wedi eu gwneud o ganlyniad i gyflwyno rhagnodi annibynnol a rhagnodi atodol ar gyfer parafeddygon cofrestredig o dan ddiwygiadau a wnaed i Reoliadau Meddyginiaethau Dynol 2012 gan Reoliadau Meddyginiaethau Dynol (Diwygio) 2018.

These amendments are made as a result of the introduction of independent prescribing and supplementary prescribing for registered paramedics under amendments made to the Human Medicines Regulations 2012 by the Human Medicines (Amendment) Regulations 2018.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by sections 47, 80, 83, 121 and 203(9) and (10) of the National Health Service (Wales) Act 2006(1), and sections 77 and 90 of, and paragraph 3 of Schedule 6 to, the Climate Change Act 2008(2) make the following Regulations.

Title, commencement and application

1.—(1) The title of these Regulations is the National Health Service (Paramedic Independent Prescriber and Paramedic Supplementary Prescriber) (Wales) (Miscellaneous Amendments) Regulations 2019 and they come into force on 22 February 2019.

(2) These Regulations apply in relation to Wales.

(ii) in paragraph (h) after “prescriber,” insert “and”;

“(ib) paramedics;”;

(d) in the definition of “supplementary prescriber” after paragraph (b)(iv)(dd) insert—

“(ee) paramedics, or”.

- (a) in sub-paragraph (2)(a), after “a therapeutic radiographer independent prescriber” insert “, a paramedic independent prescriber”;
- (b) in sub-paragraph (3) after the definition of “medicinal product” insert—
““paramedic independent prescriber” (“*parafeddyg-ragnodydd annibynnol*”) has the meaning given in regulation 2(1) of the National Health Service (Pharmaceutical Services) (Wales) Regulations 2013(2);”.

Amendments to the National Health Service (Pharmaceutical Services) (Wales) Regulations 2013

5.—(1) The National Health Service (Pharmaceutical Services) (Wales) Regulations 2013 are amended as follows.

(2) In regulation 2(1) (interpretation)—

- (a) in the appropriate place in the alphabetical order insert the following definitions—
““paramedic independent prescriber” (“*parafeddyg-ragnodydd annibynnol*”) means a person—
 - (a) who is registered as a paramedic in Part 8 of the Health and Care Professions Council register; and
 - (b) against whose name is recorded in Part 8 of that register an annotation signifying that the person is qualified to order drugs, medicines and appliances as a paramedic independent prescriber;”;
- (b) in the definition of “prescriber” after “therapeutic radiographer independent prescriber” insert “, paramedic independent prescriber”;
- (c) in paragraph (c)(i) of the definition of “supplementary prescriber” after “dietitians,” insert “paramedics,”.
