Mae'r Gorchymyn hwn yn pennu 1 Ionawr 2020 fel y diwrnod y daw'r Cod Ymarfer diwygiedig ar arfer swyddogaethau gwasanaethau cymdeithasol mewn perthynas â Rhan 10 (Eirioli) o Ddeddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 i rym ("y Cod diwygiedig").

Mae'r Cod diwygiedig wedi ei ddyroddi gan Weinidogion Cymru o dan adran 145(1) o Ddeddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 ("Deddf 2014").

Mae adran 145(3) o Ddeddf 2014 yn ei gwneud yn ofynnol i awdurdodau lleol weithredu yn unol ag unrhyw ofynion perthnasol sydd wedi eu cynnwys mewn cod a ddyroddwyd o dan adran 145(1) a rhoi sylw i unrhyw ganllawiau perthnasol sydd wedi eu cynnwys ynddo.

Mae'r Cod diwygiedig yn disodli cod cynharach a ddyroddwyd ym mis Ebrill 2016.

This Order appoints 1 January 2020 as the day on which the revised Code of Practice on the exercise of social services functions in relation to Part 10 (Advocacy) of the Social Services and Well-being (Wales) Act 2014 comes into force ("the revised Code").

The revised Code is issued by the Welsh Ministers under section 145(1) of the Social Services and Well-being (Wales) Act 2014 ("the 2014 Act").

Section 145(3) of the 2014 Act requires local authorities to act in accordance with any relevant requirements contained in a code issued under section 145(1) and to have regard to any relevant guidelines contained in it.

The revised Code replaces an earlier code issued in April 2016.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir gan adran 146(4)(b) o Ddeddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014(1) (“Deddf 2014”), yn gwneud y Gorchymyn a ganlyn.

The Welsh Ministers, in exercise of the powers conferred by section 146(4)(b) of the Social Services and Well-being (Wales) Act 2014(1) (“the 2014 Act”), make the following Order.

Mae Gweinidogion Cymru, fel sy’n ofynnol gan adran 146(1) o Ddeddf 2014, wedi ymgynghori ag unrhyw bersonau y maent yn meddwl eu bod yn addas ynghylch drafft o’r cod diwygiedig.

The Welsh Ministers, as required by section 146(1) of the 2014 Act have consulted such persons as they think fit on a draft of the revised code.

Yn unol ag adran 146(2) o Ddeddf 2014, gosodwyd drafft o’r cod diwygiedig gerbron Cynulliad Cenedlaethol Cymru am 40 niwrnod.

In accordance with section 146(2) of the 2014 Act, a draft of the revised code was laid before the National Assembly for Wales for 40 days.
