EXPLANATORY NOTE

Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pwerau a roddir gan baragraff 1(1) o Atodlen 2 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16) er mwyn ymdrin ag unrhyw fethiant yng nghyfraith yr UE a ddargedwir i weithredu'n effeithiol a diffygion eraill sy'n deillio o ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd.

These Regulations are made in exercise of the powers conferred by paragraph 1(1) of Schedule 2 to the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

Mae Mesur Teithio gan Ddysgwyr (Cymru) 2008 yn ei gwneud yn ofynnol i wregysau diogelwch gael eu ffitio ar fysiau a ddefnyddir yn gludiant i ddysgwyr. Mae'r Rheoliadau hyn yn diwygio cyfeiriad at gyfraith yr Undeb Ewropeaidd mewn darpariaeth sy'n datgan nad yw'r gofyniad i ffitio gwregysau diogelwch yn effeithio ar unrhyw safon dechnegol a fyddai fel arall yn gymwys yn rhinwedd deddfiadau penodol.

The Learner Travel (Wales) Measure 2008 requires seat belts to be fitted on buses used for learner transport. These Regulations amend a reference to European Union law in a provision stating that the requirement to fit seat belts does not affect any technical standard which would otherwise apply by virtue of certain enactments.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred by paragraph 1(1) of Schedule 2 to the European Union (Withdrawal) Act 2018(1), make the following Regulations.

The requirements of paragraph 4(2) of Schedule 7 to that Act (relating to the appropriate National Assembly for Wales scrutiny procedure for these Regulations) have been satisfied.

Title, commencement and application

1.—(1) The title of these Regulations is the Learner Travel (Wales) (Amendment) (EU Exit) Regulations 2019.

(2) These Regulations come into force on exit day.

(3) These Regulations apply in relation to Wales.

2. Yn adran 14A(5) o Fesur Teithio gan Ddysgwyr (Cymru) 2008(1), yn lle “unrhyw ofyniad yng nghyfraith yr Undeb Ewropeaidd sy’n uniongyrchol gymwysadwy” rhodder “unrhyw ofyniad yn neddfwriaeth uniongyrchol yr UE a ddargedwir”.

2. In section 14A(5) of the Learner Travel (Wales) Measure 2008(1), for “directly applicable requirement of European Union law” substitute “requirement of retained direct EU legislation”.
