Mae'r Gorchymyn hwn yn diwygio Gorchymyn Llywodraeth Leol (Cynorthwywyr i Grwpiau Gwleidyddol) (Tâl) (Cymru) 2009 (Gorchymyn 2009) er mwyn rhoi effaith i'r newidiadau i bwyntiau colofn gyflog y graddfeydd cyflog ar gyfer swyddogion llywodraeth leol a gyhoeddir gan y Cyd-gyngor Cenedlaethol ar gyfer Gwasanaethau Llywodraeth Leol.

Roedd Gorchymyn 2009 yn cysylltu uchafswm y tâl ar gyfer cynorthwywyr gwleidyddol o fewn llywodraeth leol yng Nghymru â phwynt 44 ar golofn gyflog y graddfeydd cyflog a gyhoeddir gan y Cyd-gyngor Cenedlaethol. Mae'r Cyd-gyngor Cenedlaethol wedi cyhoeddi graddfeydd cyflog newydd sy'n uno pwyntiau penodol ar y golofn, a bydd hynny'n cael effaith o 1 Ebrill 2019. Effaith hynny yw bod pwynt 44 yn dod yn bwynt 38 o 1 Ebrill 2019 ymlaen. Mae'r Gorchymyn hwn yn diwygio Gorchymyn 2009 er mwyn adlewyrchu'r newid i'r golofn gyflog ac nid yw'n diwygio'r uchafswm tâl fel y'i cyhoeddir gan y Cyd-gyngor Cenedlaethol o bryd i'w gilydd.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Local Government (Assistants for Political Groups) (Remuneration) (Wales) Order 2009 (the 2009 Order) to give effect to the changes to the spinal column points of salary scales for local government officers published by the National Joint Council for Local Government Services.

The 2009 Order linked the maximum remuneration of political assistants in local government in Wales to spinal column point 44 of the salary scale published by the National Joint Council. The National Joint Council has published new salary scales which merge certain spinal points with effect from 1 April 2019. This has the effect that point 44 becomes point 38 from 1 April 2019. This Order amends the 2009 Order to reflect the change in the spinal point and does not amend the maximum remuneration as published by the National Joint Council from time to time.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The Welsh Ministers, in exercise of the powers conferred upon the Secretary of State by section 9(4) and (4A)(1) of the Local Government and Housing Act 1989(2) and now vested in them(3), make the following Order:

Title and commencement

1. The title of this Order is the Local Government (Assistants for Political Groups) (Remuneration) (Wales) (Amendment) Order 2019 and it comes into force on 1 April 2019.
