**EXPLANATORY NOTE**

This Order appoints 8 April 2019 as the day on  
which the revised Code of Practice on the exercise of  
social services functions in relation to Part 4 (direct  
payments and choice of accommodation) and Part 5  
(charging and financial assessment) of the Social  
Services and Well-being (Wales) Act 2014 comes into  
force. This revised Code was issued by the Welsh  
Ministers under section 145(1) of the Social Services  
and Well-being (Wales) Act 2014 ("the 2014 Act") on  
5 April 2019.

Section 145(3) of the 2014 Act requires local  
authorities to act in accordance with any relevant  
requirements contained in a code issued under section  
145(1) and to have regard to any relevant guidelines  
contained in it.

Order(1).

**Title and interpretation**

1.—(1) The title of this Order is the Revised Code of  
Practice on the exercise of social services functions in  
relation to Part 4 (direct payments and choice of  
accommodation) and Part 5 (charging and financial  
assessment) of the Social Services and Well-being  
(Wales) Act 2014 (Appointed Day) Order 2019.

(2) In this Order, “the Revised Code” means the  
Code of Practice on the exercise of social services  
functions in relation to Part 4 (direct payments and  
choice of accommodation) and Part 5 (charging and  
financial assessment) of the Social Services and Well-  
being (Wales) Act 2014, a draft of which was laid, in  
accordance with section 146(2) of that Act, before the  
National Assembly for Wales on 13 February 2019  
and was issued by the Welsh Ministers on 5 April  
2019.
