**NODYN ESBONIADOL**

*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

Mae Rheoliadau Perfformiad Ysgol a Thargedau Absenoldeb (Cymru) 2011 (“Rheoliadau 2011”) yn ei gwneud yn ofynnol i gyrrf llywodraethu ysgolion a gynhelir yng Nghymru osod targedau sy’n ymwneud â pherfformiad yr ysgol a chyfraddau absenoldeb anawdurdodedig y disgylion.

Mae rheoliad 5(4) o Reoliadau 2011 (*targedau perfformiad ar gyfer disgylion a fydd ym Mlwyddyn 11*) yn ei gwneud yn ofynnol i gyrrf llywodraethu osod targedau perfformiad ar gyfer disgylion cyfnod allweddol pedwar ym Mlwyddyn 11 (gweler Rheoliadau 2011 am ddiffiniadau o “Blwyddyn 11” a “disgylion cyfnod allweddol pedwar”). Yn benodol, mae rheoliad 5 o Reoliadau 2011 yn ei gwneud yn ofynnol i’r corff llywodraethu osod targedau mewn perthynas ag—

- (a) tri chyflawniad i’w penderfynu gan y corff llywodraethu ar sail ei werthusiad o berfformiad disgylion (“targedau nas pennir”); a
- (b) y ganran o’r disgylion ym Mlwyddyn 11 sy’n cyflawni’r trothwy lefel 1 a’r trothwy lefel 2 (“targedau a bennir”).

O’r flwyddyn ysgol 2019/2020 ymlaen, a chan gynnwys y flwyddyn honno, ni fydd ysgolion yn defnyddio’r targedau a bennir. Yn lle hynny, bydd yn ofynnol i gyrrf llywodraethu ysgolion osod rhagor o dargedau nas pennir. Yn unol â hynny, mae’r Rheoliadau hyn yn diwygio rheoliad 5(4) o Reoliadau 2011 er mwyn (rheoliad 4(3))—

- (a) cynyddu nifer y targedau nas pennir o dri i chwech; a
- (b) hepgor y gofyniad i osod y targedau a bennir.

**The School Performance and  
Absence Targets (Wales)  
(Amendment) Regulations 2019**

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

The School Performance and Absence Targets (Wales) Regulations 2011 (“the 2011 Regulations”) require governing bodies of maintained schools in Wales to set targets relating to school performance and unauthorised absence rates of pupils.

Regulation 5(4) of the 2011 Regulations (*performance targets for pupils who will be in Year 11*) requires governing bodies to set performance targets for fourth key stage pupils in Year 11 (see the 2011 Regulations for definitions of “Year 11” and the “fourth key stage pupils”). In particular, regulation 5 of the 2011 Regulations requires the governing body to set targets in relation to—

- (a) three achievements to be determined by governing body based on its evaluation of pupils performance (“non-specified targets”); and
- (b) for the percentage of pupils in Year 11 to achieve the level 1 threshold and the level 2 threshold (“specified targets”).

From and including the 2019/2020 school year the specified targets will not be used by schools. Instead school governing bodies will be required to set more non-specified targets. Accordingly these Regulations amend regulation 5(4) of the 2011 Regulations so as to (regulation 4(3))—

- (a) increase the number of non-specified targets from three to six; and
- (b) omit the requirement to set the specified targets.

Mae'r Rheoliadau hyn hefyd yn diwygio rheoliad 2(1) o Reoliadau 2011 er mwyn hepgor rhai diffiniadau nad ydynt ond yn berthnasol i'r targedau a bennir (rheoliad 4(2)).

Mae rheoliad 8 o Reoliadau 2011 (*cyhoeddi gwybodaeth*) yn ei gwneud yn ofynnol i gyrrf llywodraethu gyhoeddi, yn adroddiad blynnyddol yr ysgol, y ganran o'r disgylion ym Mlwyddyn 11 sydd (gweler Rheoliadau 2011 am y diffiniad o "adroddiad blynnyddol yr ysgol") (rheoliad 4(4))—

- (a) yn cyflawni'r tri tharged nas pennir; a
- (b) yn cyflawni'r targedau a bennir.

O ganlyniad i'r diwygiad i reoliad 5(4) o Reoliadau 2011, mae'r Rheoliadau hyn hefyd yn diwygio rheoliad 8(3) o Reoliadau 2011—

- (a) fel bod rhaid i'r corff llywodraethu adrodd am y ganran o'r disgylion ym Mlwyddyn 11 sy'n cyflawni'r chwe tharged nas pennir; a
- (b) fel na fydd rhaid i'r corff llywodraethu adrodd mwyach am y ganran o'r disgylion sy'n cyflawni'r targedau a bennir.

Bydd y newidiadau a wneir gan y Rheoliadau hyn yn cymryd effaith am y tro cyntaf yn y flwyddyn ysgol 2019 i 2020 ("y flwyddyn drosiannol"). Felly, ni fydd cyrff llywodraethu wedi gosod targedau yn y flwyddyn ysgol flaenorol sy'n gallu ffurffio'r sail ar gyfer eu targedau adolygedig a'u targedau terfynol yn y flwyddyn drosiannol. Bydd y targedau blaenorol wedi cael eu gosod yn erbyn mesurau perfformiad nad ydynt yn cael eu defnyddio mwyach. Mae rheoliad 3 yn gwneud darpariaeth drosiannol sy'n caniatáu i'r corff llywodraethu osod targedau dros dro a thargedau terfynol ar gyfer y flwyddyn drosiannol nad ydynt yn seiliedig ar dargedau a osodwyd mewn blynnyddoedd ysgol blaenorol.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Gellir cael copi oddi wrth yr Is-adran Cwricwlwm ac Asesu yn yr Adran Addysg a Gwasanaethau Cyhoeddus yn Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

These Regulations also amend regulation 2(1) of the 2011 Regulations so as to omit some definitions relevant only to the specified targets (regulation 4(2)).

Regulation 8 of the 2011 Regulations (*publication of information*) requires governing bodies to publish in the school's annual report the percentage of pupils in Year 11 who (see the 2011 Regulations for the definition of "school's annual report") (regulation 4(4))—

- (a) achieve the three non-specified targets; and
- (b) achieve the specified targets.

As a consequence of the amendment to regulation 5(4) of the 2011 Regulations these Regulations also amend regulation 8(3) of the 2011 Regulations so that the governing body—

- (a) must report the percentage of pupils in Year 11 who achieve the six non-specified targets; and
- (b) will no longer have to report on the percentage of pupils to achieve the specified targets.

The changes made by these Regulations will take effect for the first time in the school year 2019 to 2020 ("the transitional year"). Therefore governing bodies will not have set targets in the previous school year which can form the basis of its reviewed and final targets in the transitional year. The previous targets will have been set against performance measures which are no longer used. Regulation 3 makes transitional provision which allows the governing body to set provisional and final targets for the transitional year which are not based on targets set in previous school years.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers in exercise of the powers conferred on the Secretary of State by sections 19 and 54(3) and (4) of the Education Act 1997(1) and sections 30(1) and (2) and 210 of the Education Act 2002(2) and now vested in them(3), make the following Regulations:

**Title and commencement**

1.—(1) The title of these Regulations is the School Performance and Absence Targets (Wales) (Amendment) Regulations 2019.

(2) These Regulations come into force on 1 September 2019.

**2.** Yn y Rheoliadau hyn, ystyr “Rheoliadau 2011” yw Rheoliadau Perfformiad Ysgol a Thargedau Absenoldeb (Cymru) 2011(1).

## **Trosiannol**

**3.** Yn rheoliad 5(3) o Reoliadau 2011—

- (a) yn is-baragraff (a), mae'r geiriau “, sef y targedau adolygedig a osodwyd yn y flwyddyn ysgol flaenorol” i'w trin fel pe baent wedi eu hepgor ar gyfer y flwyddyn ysgol(2) 2019 i 2020; a
- (b) yn is-baragraff (b), mae'r geiriau “sef y targedau dros dro a osodwyd yn y flwyddyn ysgol flaenorol ond a ddiwygir os yw'r corff llywodraethu yn barnu ei bod yn angenrheidiol gwneud hynny” i'w trin fel pe baent wedi eu hepgor ar gyfer y flwyddyn ysgol 2019 i 2020.

## **Diwygio**

**4.—(1)** Mae Rheoliadau 2011 wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2—

- (a) ym mharagraff (1), hepgorer y diffiniadau o “arholiad TGAU”, “FfCC”, “lefel FfCC”, “TGAU”, “trothwy lefel 1” a “trothwy lefel 2”; a
- (b) hepgorer paragraff (2).

(3) Yn rheoliad 5—

(a) yn lle paragraff (4) rhodder—

“(4) Y chwe chyflawniad a osodwyd gan y corff llywodraethu ar sail ei werthusiad o berfformiad disgylion yn yr ysgol mewn perthynas â'r flwyddyn ysgol flaenorol.”; a

(b) hepgorer paragraff (5).

(4) Yn rheoliad 8, yn lle paragraff (3) rhodder—

“(3) Yn y rheoliad hwn, ystyr “canlyniadau cyrhaeddiad disgylion” yw'r ganran sy'n cyflawni'r chwe chyflawniad a osodwyd gan y corff llywodraethu yn unol â rheoliad 5(4).”

## **Interpretation**

**2.** In these Regulations, “the 2011 Regulations” means the School Performance and Absence Targets (Wales) Regulations 2011(1).

## **Transitional**

**3.** In regulation 5(3) of the 2011 Regulations—

- (a) in sub-paragraph (a), the words “, being the reviewed targets set in the previous school year” are to be treated as if they were omitted for the school year(2) 2019 to 2020; and
- (b) in sub-paragraph (b), the words “, being the provisional targets set in the previous school year but revised if the governing body deem it necessary to do so” are to be treated as if they were omitted for the school year 2019 to 2020.

## **Amendment**

**4.—(1)** The 2011 Regulations are amended as follows.

(2) In regulation 2—

- (a) in paragraph (1), omit the definitions of “GCSE”, “GCSE examination”, “level 1 threshold”, “level 2 threshold”, “NQF” and “NQF level”; and
- (b) omit paragraph (2).

(3) In regulation 5—

(a) for paragraph (4) substitute—

“(4) The six achievements set by the governing body based on its evaluation of the performance of pupils at the school in relation to the previous school year.”; and

(b) omit paragraph (5).

(4) In regulation 8, for paragraph (3) substitute—

“(3) In this regulation, “pupils’ attainment results” means the percentage who achieve the six achievements set by the governing body in accordance with regulation 5(4).”
