Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cynlluniau Strategol Cymraeg mewn Addysg (Cymru) 2019 (O.S. 2019/1489 (Cy. 269)) ("Rheoliadau 2019") fel bod y gofyniad ar awdurdodau lleol yng Nghymru i gyflwyno eu cynllun deng mlynedd cyntaf erbyn 31 Ionawr 2021 wedi ei ddiwygio i 31 Ionawr 2022. O ganlyniad i'r Rheoliadau hyn, bydd y cynllun 10 mlynedd cyntaf hwnnw yn cael effaith ar 1 Medi 2022 tan 31 Awst 2032 (yn hytrach na 1 Medi 2021 tan 31 Awst 2031).

Mae'r Rheoliadau hyn hefyd yn diwygio'r gofyniad i gyflwyno'r adroddiad adolygu cyntaf heb fod yn hwyrach na 31 Gorffennaf 2022 fel bod yr adroddiad adolygu cyntaf i'w gyflwyno heb fod yn hwyrach na 31 Gorffennaf 2023.

Mae'r diwygiadau hyn wedi eu gwneud mewn ymateb i ledaeniad coronafeirws syndrom anadol aciwt difrifol 2 (SARS-CoV-2) yng Nghymru a'r pwysau o ganlyniad i hynny ar awdurdodau lleol. O ganlyniad nid ystyrir ei bod yn rhesymol nac yn briodol ei gwneud yn ofynnol i awdurdodau lleol lunio eu cynlluniau yn unol â Rheoliadau 2019 ac ymgynghori arnynt cyn eu cyflwyno i Weinidogion Cymru i'w cymeradwyo erbyn 31 Ionawr 2021.

The Welsh in Education Strategic
Plans (Wales) (Amendment)
(Coronavirus) Regulations 2020

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations make amendments to the Welsh in Education Strategic Plans (Wales) Regulations 2019 (S.I. 2019/1489 (W. 269)) ("the 2019 Regulations") so that the requirement on local authorities in Wales to submit their first ten year plan by 31 January 2021 is amended to 31 January 2022. As a result of these Regulations, that first 10 year plan will have effect on 1 September 2022 until 31 August 2032 (instead of 1 September 2021 until 31 August 2031).

These Regulations also amend the requirement to submit the first review report no later than 31 July 2022 so that the first review report is to be submitted no later than 31 July 2023.

These amendments are made in response to the spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales and the resulting pressures on local authorities. As a result it is not considered reasonable or appropriate to require local authorities to prepare their plans in accordance with the 2019 Regulations and to consult on them prior to submission to the Welsh Ministers for approval by 31 January 2021.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh in Education Strategic Plans (Wales) (Amendment) (Coronavirus) Regulations 2020

Made	2 November 2020
Laid before Senedd Cymru	4 November 2020
Coming into force	1 December 2020

The Welsh Ministers, in exercise of the powers conferred upon them by sections 87 and 97 of the School Standards and Organisation (Wales) Act 2013(1), make the following Regulations:

Title and commencement

1.—(1) The title of these Regulations is the Welsh in Education Strategic Plans (Wales) (Amendment) (Coronavirus) Regulations 2020.

(2) These Regulations come into force on 1 December 2020.

Amendment of the Welsh in Education Strategic Plans (Wales) Regulations 2019

2.—(1) The Welsh in Education Strategic Plans (Wales) Regulations 2019(2) are amended as follows.

(2) In regulation 4(1) (duration of ten year plans)—

(a) for “1 September 2021” substitute “1 September 2022”;

(b) for “31 August 2031” substitute “31 August 2032”.

(3) In regulation 5(1) (submission of ten year plans to the Welsh Ministers), for “31 January 2021” substitute “31 January 2022”.
