Mae'r Rheoliadau hyn wedi eu gwneud drwy arfer y pwerau a roddir i Weinidogion Cymru gan baragraff 1 o Atodlen 2 a pharagraff 21 o Atodlen 7 i Ddeddf yr Undeb Ewropeaidd (Ymadael) 2018 (p. 16), er mwyn ymdrin ag unrhyw fethiant yng nghyfraith yr UE a ddargedwir i weithredu'n effeithiol a diffygion eraill sy'n deillio o ymadawiad y Deyrnas Unedig â'r Undeb Ewropeaidd.

Maent hefyd wedi eu gwneud drwy arfer y pwerau yn adran 132 o Ddeddf Addysg 2002 (p. 32).

Mae'r Rheoliadau hyn yn gwneud diwygiadau technegol i Reoliadau Cymwysterau Athrawon (Diwygio) (Cymru) (Ymadael â'r UE) 2019 (O.S. 2019/444 (Cy. 107)). Mae'r diwygiadau technegol hyn yn codi o ganlyniad i ddiwygiadau a wneir i Reoliadau Cydnabod Cymwysterau Proffesiynol (Diwygio etc.) (Ymadael â'r UE) 2019 (O.S. 2019/312) gan Reoliadau Cymwysterau a Gwasanaethau Proffesiynol (Diwygiadau a Darpariaethau Amrywiol) (Ymadael â'r UE) 2020 (O.S. 2020/1038).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**The Teachers' Qualifications
(Amendment) (Wales) (EU Exit)
Regulations 2020**

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of the powers conferred on the Welsh Ministers by paragraph 1 of Schedule 2 and paragraph 21 of Schedule 7 to, the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies arising from the withdrawal of the United Kingdom from the European Union.

They are also made in exercise of the powers in section 132 of the Education Act 2002 (c. 32).

These Regulations make technical amendments to the Teachers' Qualifications (Amendment) (Wales) (EU Exit) Regulations 2019 (S.I. 2019/444 (W. 107)). These technical amendments arise as a result of amendments which are made to the Recognition of Professional Qualifications (Amendment etc.) (EU Exit) Regulations 2019 (S.I. 2019/312) by the Professional Qualifications and Services (Amendments and Miscellaneous Provisions) (EU Exit) Regulations 2020 (S.I. 2020/1038).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cymwysterau Athrawon (Diwygio) (Cymru) (Ymadael â'r UE) 2020.

(2) Daw'r Rheoliadau hyn i rym ar ddiwrnod cwblhau'r cyfnod gweithredu.

(3) Yn y Rheoliadau hyn, mae i "diwrnod cwblhau'r cyfnod gweithredu" yr ystyr a roddir i "IP completion day" yn adran 39(1) i (5) o Ddeddf yr Undeb Ewropeaidd (Y Cytundeb Ymadael) 2020(1).

Diwygio Rheoliadau Cymwysterau Athrawon (Diwygio) (Cymru) (Ymadael â'r UE) 2019

2.—(1) Mae rheoliad 3(2) o Rheoliadau Cymwysterau Athrawon (Diwygio) (Cymru) (Ymadael â'r UE) 2019(2) wedi ei ddiwygio fel a ganlyn.

(2) Yn is-baragraff (1)(c) o baragraff 4 a amnewidiwyd o Atodlen 2, yn lle "paragraff 48" rhodder "paragraff 50 neu baragraff 51".

Title, commencement and interpretation

1.—(1) The title of these Regulations is the Teachers' Qualifications (Amendment) (Wales) (EU Exit) Regulations 2020.

(2) These Regulations come into force on IP completion day.

(3) In these Regulations, "IP completion day" has the meaning given in section 39(1) to (5) of the European Union (Withdrawal Agreement) Act 2020(1).

Amendment of the Teachers' Qualifications (Amendment) (Wales) (EU Exit) Regulations 2019

2.—(1) Regulation 3(2) of the Teachers' Qualifications (Amendment) (Wales) (EU Exit) Regulations 2019(2) is amended as follows.

(2) In sub-paragraph (1)(c) of the substituted paragraph 4 of Schedule 2, for "paragraph 48" substitute "paragraph 50 or paragraph 51".
