Mae'r Rheoliadau hyn yn diwygio Atodlen 1 i Ddeddf Deddfwriaeth (Cymru) 2019, sy'n gwneud darpariaeth ynghylch ystyr geiriau ac ymadroddion penodol pan fyddant yn ymddangos yn Neddffau Senedd Cymru ac mewn is-offerynnau Cymreig. Mae'r geiriau a'r ymadroddion i'w dehongli yn unol ag Atodlen 1 ac eithrio i'r graddau y mae darpariaeth ddatganedig yn cael ei gwneud i'r gwrthwyneb neu y mae'r cyd-destun yn mynnu fel arall.

These Regulations amend Schedule 1 to the Legislation (Wales) Act 2019, which makes provision about the meaning of certain words and expressions when they appear in Acts of Senedd Cymru and Welsh subordinate instruments. The words and expressions are to be interpreted in accordance with Schedule 1 except so far as express provision is made to the contrary or the context requires otherwise.

Mae'r Rheoliadau yn mewnosod darpariaethau yn Atodlen 1 ynghylch ystyr yr ymadroddion a ganlyn—

The Regulations insert provisions into Schedule 1 about the meaning of the following expressions—

“Cod Dedfrydu”;

“Equality and Human Rights Commission”;

“Comisiwn Cydraddoldeb a Hawliau Dynol”;

“National Trust”;

“Pwyllgor Cyfrifon Cyhoeddus”;

“Public Accounts Committee”;

“Ymddiriedolaeth Genedlaethol”.

“Sentencing Code”.

Maent hefyd yn diwygio'r diffiniad o'r “graddfa safonol” o ddirwyon am droseddau diannod o ganlyniad i'r Cod Dedfrydu (yr ailddatganiad o'r ddeddfwriaeth ddedfrydu a nodir yn Neddff Dedfrydu 2020).

They also amend the definition of the “standard scale” of fines for summary offences as a consequence of the Sentencing Code (the restatement of sentencing legislation set out in the Sentencing Act 2020).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pŵer a roddir iddynt gan adran 6(2) o Ddeddf Deddfwriaeth (Cymru) 2019(1).

The Welsh Ministers make the following Regulations in exercise of the power conferred on them by section 6(2) of the Legislation (Wales) Act 2019(1).

Gosodwyd drafft o'r offeryn hwn gerbron Senedd Cymru ac fe'i cymeradwywyd ganddi drwy benderfyniad yn unol ag adran 43(2) o'r Ddeddf honno.

A draft of this instrument has been laid before and approved by a resolution of Senedd Cymru in accordance with section 43(2) of that Act.

Enwi a dod i rym

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Deddf Deddfwriaeth (Cymru) 2019 (Diwygio Atodlen 1) 2020.

(2) Deuant i rym drannoeth y diwrnod y'u gwneir.

Title and coming into force

1.—(1) The title of these Regulations is the Legislation (Wales) Act 2019 (Amendment of Schedule 1) Regulations 2020.

(2) They come into force on the day after the day on which they are made.

2.—(1) Mae'r Tabl yn Atodlen 1 i Ddeddf Deddfwriaeth (Cymru) 2019 (diffiniadau o eiriau ac ymadroddion sy'n ymddangos yn Neddffau Senedd Cymru ac mewn is-offerynnau Cymreig) wedi ei ddiwygio fel a ganlyn.

(2) Mewnosoder y cofnodion a ganlyn yn y lleoedd priodol yn nhrefn yr wyddor—

**Amendments to Schedule 1 to the Legislation
(Wales) Act 2019**

2.—(1) The Table in Schedule 1 to the Legislation (Wales) Act 2019 (definitions of words and expressions appearing in Acts of Senedd Cymru and Welsh subordinate instruments) is amended as follows.

(2) Insert the following entries in the appropriate places in alphabetical order—

(1) 2019 dccc 4, a ddiwygiwyd gan Ddeddf Senedd ac Etholiadau (Cymru) 2020 (dccc 1), Atodlen 1, paragraff 5. Mae diwygiadau eraill nad ydynt yn berthnasol i'r offeryn hwn.

(1) 2019 anaw 4, amended by the Senedd and Elections (Wales) Act 2020 (anaw 1), Schedule 1, paragraph 5. There are other amendments not relevant to this instrument.

(3) In the definition of “standard scale”, after “meaning given” insert—

- (a) in the case of an offence of which the offender is convicted on or after 1 December 2020, by section 122 of the Sentencing Code;
- (b) in the case of an offence of which the offender was convicted before that date.”.
