Diwygiodd Rheoliadau 2020 Reoliadau Addysg (Trefniadau Apelau Derbyn) (Cymru) 2005, o dan amgylchiadau penodol sy'n ymwneud â mynchyder neu drosglwyddiad y coronafeirws, er mwyn caniatáu—

- (a) panelau apêl a chanddynt ddu aelod, a
- (b) i banelau apêl gynnal gwrandawiadau drwy fynediad o bell neu benderfynu apelau ar sail gwybodaeth ysgrifenedig.

Mae rheoliad 2(2) o Reoliadau 2020 yn darparu bod y diwygiadau hynny yn peidio â chael effaith ar 31 Ionawr 2021.

Prif effaith rheoliad 2 o'r Rheoliadau hyn yw diwygio'r dyddiad 31 Ionawr 2021 yn Rheoliadau 2020 i 30 Medi 2021. Golyga hyn fod y diwygiadau a wneir gan Reoliadau 2020 yn parhau i gael effaith tan 30 Medi 2021.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ni luniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Education (Admission Appeals Arrangements) (Wales) (Coronavirus) (Amendment) Regulations 2020 ("the 2020 Regulations").

The 2020 Regulations amended the Education (Admission Appeals Arrangements) (Wales) Regulations 2005, in certain circumstances relating to the incidence or transmission of coronavirus, to allow—

- (a) appeal panels of two members, and
- (b) appeal panels to hold hearings by remote access or to decide appeals on the basis of written information.

Regulation 2(2) of the 2020 Regulations provides that those amendments cease to have effect on 31 January 2021.

The main effect of regulation 2 of these Regulations is that the date of 31 January 2021 in the 2020 Regulations is amended to 30 September 2021. This means that the amendments made by the 2020 Regulations continue to have effect until 30 September 2021.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has not been prepared as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers in exercise of the powers conferred on the Secretary of State by sections 94(5) and (5A), 95(3) and (3A) and 138(7) of the Schools Standards and Framework Act 1998(1) and now vested in them(2) make the following Regulations:

Title and commencement

1. The title of these Regulations is the Education (Admission Appeals Arrangements) (Wales) (Coronavirus) (Amendment) (Amendment) Regulations 2020 and they come into force on 30 January 2021.

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol o dan yr adrannau hyn i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynlliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672) ac yna i Weinidogion Cymru gan baragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p. 32).

(1) 1998 c. 31; *see* section 142(1) for the definitions of "the Assembly", "prescribed" and "Regulations". Subsection (5A) was inserted into section 94 by section 50 of the Education Act 2002 (c. 32). Subsection (3A) was inserted into section 95 by paragraph 9 of Schedule 4 to the Education Act 2002.

(2) The functions of the Secretary of State under these sections were transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672) and then to the Welsh Ministers by paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c. 32).

(3) Yn rheoliad 2(2), yn lle “31 Ionawr 2021” rhodder “30 Medi 2021”.

(4) Yn rheoliad 4(a), yn lle “1 Chwefror 2021” rhodder “1 Hydref 2021”.

(5) Yn rheoliad 4(b), yn lle “31 Ionawr 2021” rhodder “30 Medi 2021”.

Amendment of the Education (Admission Appeals Arrangements) (Wales) (Coronavirus) (Amendment) Regulations 2020

2.—(1) The Education (Admission Appeals Arrangements) (Wales) (Coronavirus) (Amendment) Regulations 2020(1) are amended as follows.

(2) In regulation 1(2)(a), for “31 January 2021” substitute “30 September 2021”.

(3) In regulation 2(2), for “31 January 2021” substitute “30 September 2021”.

(4) In regulation 4(a), for “1 February 2021” substitute “1 October 2021”.

(5) In regulation 4(b), for “31 January 2021” substitute “30 September 2021”.
