**The Addition of Vitamins, Minerals
and Other Substances (Wales)
(Amendment) Regulations 2020**

NODYN ESBONIADOL

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007 (O.S. 2007/1984 (Cy. 165)) ("Rheoliadau 2007").

Mae rheoliad 2(1) o Reoliadau 2007 wedi ei ddiwygio fel bod y diffiniad o "y Rheoliad CE" yn cynnwys cyfeiriad at Atodiad 3 (fel y'i diwygir o bryd i'w gilydd) o Reoliad (EC) Rhif 1925/2006 Senedd Ewrop a'r Cyngor dyddiedig 20 Rhagfyr 2006 ar ychwanegu fitaminau a mwynau a sylweddau eraill penodol at fwydydd (OJ Rhif L 404, 30.12.2006, t. 26), fel y'i diwygiwyd ddiwethaf gan Reoliad y Comisiwn (EU) 2019/650 dyddiedig 24 Ebrill 2019 sy'n diwygio Atodiad 3 i Reoliad (EC) Rhif 1925/2006 Senedd Ewrop a'r Cyngor ynghylch Yohimbe (Pausinystalia yohimbe (K. Schum) Pierre ex Beille) (OJ Rhif L 110, 25.4.2019, t. 21).

Mae rheoliad 4(2) o Reoliadau 2007 wedi ei ddiwygio fel ei bod yn drosedd ychwanegu sylwedd a restrir yn Atodiad 3, Rhan A o'r Rheoliad CE at fwydydd, neu ddefnyddio sylwedd o'r fath wrth weithgynhyrchu bwydydd.

Mae rheoliad 4(2) o Reoliadau 2007 wedi ei ddiwygio ymhellach fel ei bod yn drosedd ychwanegu sylwedd a restrir yn Atodiad 3, Rhan B o'r Rheoliad CE at fwydydd, neu ddefnyddio sylwedd o'r fath wrth weithgynhyrchu bwydydd oni bai bod y sylwedd hwnnw yn cael ei ychwanegu neu ei ddefnyddio yn unol â'r amodau a bennir yn y Rhan honno.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007 (S.I. 2007/1984 (W. 165)) ("the 2007 Regulations").

Regulation 2(1) of the 2007 Regulations is amended so that the definition of "the EC Regulation" includes a reference to Annex 3 (as it may be amended from time to time) of Regulation (EC) No 1925/2006 of the European Parliament and of the Council of 20 December 2006 on the addition of vitamins and minerals and of certain other substances to foods (OJ No. L 404, 30.12.2006, p. 26), as last amended by Commission Regulation (EU) 2019/650 of 24 April 2019 amending Annex 3 to Regulation (EC) No 1925/2006 of the European Parliament and of the Council as regards Yohimbe (Pausinystalia yohimbe (K. Schum) Pierre ex Beille) (OJ No. L 110, 25.4.2019, p. 21).

Regulation 4(2) of the 2007 Regulations is amended so that it is an offence to add a substance listed in Annex 3, Part A of the EC Regulation to foods, or to use such a substance in the manufacture of foods.

Regulation 4(2) of the 2007 Regulations is further amended so that it is an offence to add a substance listed in Annex 3, Part B to the EC Regulation to foods, or to use such a substance in the manufacture of foods unless that substance is added or used in accordance with the conditions specified in that Part.

Mae darpariaeth drosiannol newydd (rheoliad 4A) wedi ei mewnosod yn Rheoliadau 2007 i ddarparu nad oes unrhyw drosedd yn cael ei chyflawni mewn cysylltiad ag unrhyw fwyd nad yw'n cydymffurfio â darpariaethau Atodiad 3, Rhan B sy'n ymwneud â thraws-fraster ac eithrio traws-fraster sy'n digwydd yn naturiol mewn braster sy'n dod o anifeiliaid ac a roddir ar y farchnad cyn 1 Ebrill 2021.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

A new transitional provision (regulation 4A) is inserted into the 2007 Regulations to provide that no offence is committed in respect of any food that does not comply with the provisions of Annex 3, Part B relating to trans fat other than trans fat naturally occurring in fat of animal origin and which is placed on the market before 1 April 2021.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddir gan adrannau 16(1)(a) ac (f), 17(2), 26(1)(a) a (3) ac 48(1) o Ddeddf Diogelwch Bwyd 1990(1) ac a freiniwyd bellach ynddynt hwy(2) ac adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(3) a pharagraff 1A o Atodlen 2 iddi.

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(a) and (f), 17(2), 26(1)(a) and (3) and 48(1) of the Food Safety Act 1990(1) and now vested in them(2) and section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(3).

Mae Gweinidogion Cymru wedi eu dynodi at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972 mewn perthynas â mesurau sy'n ymwneud â bwyd (gan gynnwys diod) gan gynnwys cynhyrchu sylfaenol o ran bwyd(1). Mae'r Rheoliadau hyn yn gwneud darpariaeth at ddiben a grybwyllir yn adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972, ac mae'n ymddangos i Weinidogion Cymru ei bod yn hwylus i gyfeiriadau penodol at ddarpariaethau yn Rheoliad (EC) Rhif 2016/128(2) gael eu dehongli fel cyfeiriadau at y darpariaethau hynny fel y'u diwygir o bryd i'w gilydd.

Mae Gweinidogion Cymru wedi rhoi sylw i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd yn unol ag adran 48(4A) o Ddeddf Diogelwch Bwyd 1990(3).

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(4), ymgynghorwyd yn agored ac yn dryloyw â'r cyhoedd wrth lunio a gwerthuso'r Rheoliadau hyn.

Enwi a chychwyn

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) (Diwygio) 2020.

(2) Daw'r Rheoliadau hyn i rym ar 3 Ebrill 2020.

The Welsh Ministers have been designated for the purposes of section 2(2) of the European Communities Act 1972 in relation to measures relating to food (including drink) including the primary production of food(1). These Regulations make provision for a purpose mentioned in section 2(2) of the European Communities Act 1972, and it appears to the Welsh Ministers that it is expedient for certain references to provisions of Regulation (EC) No 2016/128(2) to be construed as references to those provisions as amended from time to time.

The Welsh Ministers have had regard to relevant advice given by the Food Standards Agency in accordance with section 48(4A) of the Food Safety Act 1990(3).

As required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(4), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Title and commencement

1.—(1) The title of these Regulations is the Addition of Vitamins, Minerals and Other Substances (Wales) (Amendment) Regulations 2020.

(2) These Regulations come into force on 3 April 2020.

Diwygio Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007

2.—(1) Mae Rheoliadau Ychwanegu Fitaminau, Mwynau a Sylweddau Eraill (Cymru) 2007(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 2(1) (dehongli), yn y diffiniad o “y Rheoliad CE” (“*the EC Regulation*”) yn lle “I neu II” rhodder “1, 2 neu 3”.

(3) Yn rheoliad 4(2) (tramgwyddau a chosbau)—

- (a) ar ddiwedd is-baragraff (ch) hepgorer “a”;
- (b) ar ddiwedd is-baragraff (d) yn lle “.” rhodder “,”;

(c) ar ôl is-baragraff (d) mewnosoder—

“(dd) Erthygl 8(2)(a)(i) (gwahardd ychwanegu sylwedd a restrir yn Atodiad 3, Rhan A at fwydydd neu ei ddefnyddio wrth weithgynhyrchu bwydydd);

(e) Erthygl 8(2)(a)(ii) (gwahardd ychwanegu sylwedd a restrir yn Atodiad 3, Rhan B at fwydydd neu ei ddefnyddio wrth weithgynhyrchu bwydydd oni bai bod y sylwedd hwnnw yn cael ei ychwanegu neu ei ddefnyddio yn unol â’r amodau a bennir yn y Rhan honno).”

Amendment of the Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007

2.—(1) The Addition of Vitamins, Minerals and Other Substances (Wales) Regulations 2007(1) are amended as follows.

(2) In regulation 2(1) (interpretation), in the definition of “the EC Regulation” (“*y Rheoliad CE*”) for “I or II” substitute “1, 2 or 3”.

(3) In regulation 4(2) (offences and penalties)—

- (a) at the end of sub-paragraph (d) omit “and”;
- (b) at the end of sub-paragraph (e) for “.” substitute “,”;

(c) after sub-paragraph (e) insert—

“(f) Article 8(2)(a)(i) (prohibition of the addition of a substance listed in Annex 3, Part A to foods or its use in the manufacture of foods);

(g) Article 8(2)(a)(ii) (prohibition of the addition of a substance listed in Annex 3, Part B to foods or its use in the manufacture of foods unless that substance is added or used in accordance with the conditions specified in that Part).”

(4) After regulation 4 insert—

“Transitional provision in relation to food containing substance listed in Annex 3, Part B

4A. An offence is not committed under paragraph (1) of regulation 4 by virtue of paragraph (2)(g) of that regulation in respect of the addition of a substance to, or its use in the manufacture of, any food if—

- (a) the food is placed on the market before 1 April 2021; and
- (b) the substance concerned falls within the entry in Annex 3, Part B relating to trans fat other than trans fat naturally occurring in fat of animal origin.”
