Mae adran 32A o Ddeddf Addysg 2002 yn ei gwneud yn ofynnol i awdurdod lleol benderfynu ar ddyddiadau tymhorau ar gyfer pob ysgol gymunedol, ysgol wirfoddol a reolir, ysgol arbennig gymunedol neu ysgol feithrin a gynhelir yn ei ardal. Wrth wneud hynny, rhaid i awdurdodau lleol gydweithredu a chydgysylltu â'i gilydd ac â chyrrff llywodraethu perthnasol yn eu hardal i sicrhau bod dyddiadau tymhorau ysgol ar gyfer ysgolion a gynhelir yr un fath (neu mor debyg ag y gallant fod).

Mae Rheoliadau Addysg (Hysbysu am Ddyddiadau Tymhorau Ysgol) (Cymru) 2014 (O.S. 2014/1249 (Cy. 130)) ("Rheoliadau 2014") yn darparu bod rhaid i awdurdodau lleol hysbysu Gweinidogion Cymru am y dyddiadau ysgol y penderfynwyd arnynt o leiaf ddwy flynedd ymlaen llaw (h.y. erbyn y diwrnod gwaith olaf ym mis Awst ddwy flynedd cyn y flwyddyn ysgol o dan sylw).

Mae'r Rheoliadau hyn, sydd wedi eu gwneud o dan adran 32A a 210 o Ddeddf Addysg 2002, yn diwygio Rheoliadau 2014 fel bod rhaid i'r hysbysiad ar gyfer y flwyddyn ysgol 2022-23 gael ei anfon at Weinidogion Cymru erbyn 31 Rhagfyr 2020. Mae ysgolion ac awdurdodau lleol yn debygol o fod o dan fwy o bwysau dros yr haf oherwydd lledaeniad coronafeirws syndrom anadlol aciwt difrifol 2 (SARS-CoV-2) yng Nghymru. Mae'r gofyniad i hysbysu Gweinidogion Cymru am ddyddiadau tymor erbyn 31 Awst 2020 yn debygol o osod baich gweinyddol anghymesur ar awdurdodau lleol. Bydd estyn y dyddiad cau ar gyfer

EXPLANATORY NOTE

(This note is not part of the Regulations)

Section 32A of the Education Act 2002 requires a local authority to determine the term dates for each community, voluntary controlled or community special school or maintained nursery school in its area. In doing so, local authorities must co-operate and co-ordinate with each other and with relevant governing bodies in their area to ensure that school terms dates for maintained schools are the same (or as similar as can be).

The Education (Notification of School Term Dates) (Wales) Regulations 2014 (S.I. 2014/1249 (W. 130)) ("the 2014 Regulations") provide that local authorities must notify the Welsh Ministers of the school dates determined at least two years in advance (i.e. by the final working day in August two years before the school year in question).

These Regulations, which are made under section 32A and 210 of the Education Act 2002, amend the 2014 Regulations so that the notice for the school year 2022-23 must be sent to the Welsh Ministers by 31 December 2020. Schools and local authorities are likely to be under increased pressure over the summer due to spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales. The requirement to notify Welsh Ministers of term dates by 31 August 2020 is likely to place a disproportionate administrative burden on local authorities. Extending the notification deadline to 31 December 2020 will

The Welsh Ministers, in exercise of the powers conferred on them by sections 32A and 210 of the Education Act 2002(1), make the following Regulations:

1. Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Hysbysu am Ddyddiadau Tymhorau Ysgol) (Cymru) (Diwygio) (Coronafeirws) 2020 a deuant i rym ar 16 Gorffennaf 2020.

Title and commencement

1. The title of these Regulations is the Education (Notification of School Term Dates) (Wales) (Amendment) (Coronavirus) Regulations 2020 and they come into force on 16 July 2020.

2. Regulation 4 of the Education (Notification of School Term Dates) (Wales) Regulations 2014(2) is amended as follows—

- (a) the existing provision becomes paragraph (1);
- (b) at the beginning of paragraph (1) insert “Subject to paragraph (2),”;
