Mae'r Rheoliadau hyn wedi eu gwneud o dan Ddeddf Addysgu ac Addysg Uwch 1998 ("Deddf 1998") ac maent yn diwygio—

- (a) Rheoliadau Addysg (Cymorth i Fyfyrwyr) (Cymru) 2017 ("Rheoliadau 2017"), a
- (b) Rheoliadau Addysg (Cymorth i Fyfyrwyr) (Cymru) 2018 ("Rheoliadau 2018").

Mae Rheoliadau 2017 yn darparu ar gyfer cymorth ariannol i fyfyrwyr cymwys sy'n dilyn cyrsiau addysg uwch dynodedig sy'n dechrau cyn 1 Medi 2018. Mae Rhan 2 o'r Rheoliadau hyn yn diwygio rheoliad 62 o Reoliadau 2017 sy'n ymneud, ymhllith petau eraill, ag adenennill gan Weinidogion Cymru ordaliadau o fenthyciadau at gostau byw. Nid yw'r ffordd y caiff Gweinidogion Cymru adenennill gordaliadau o'r fath yn dibynnu mwyach ar ba un a yw myfyriwr wedi methu â darparu gwybodaeth neu wedi darparu gwybodaeth anghywir. Mae rheoliad 62 hefyd yn galluogi Gweinidogion Cymru i'w gwneud yn ofynnol i myfyriwr ad-dalu gordaliad yn unol â rheoliadau a wneir o dan adran 22 o Ddeddf 1998.

Mae Rheoliadau 2018 yn darparu ar gyfer cymorth ariannol i fyfyrwyr cymwys sy'n dilyn cyrsiau addysg uwch dynodedig sy'n dechrau ar neu ar ôl 1 Medi 2018. Mae Rhan 3 o'r Rheoliadau hyn yn diwygio Rheoliadau 2018.

EDUCATION, WALES

The Education (Student Support) (Miscellaneous Amendments) (Wales) (No. 2) Regulations 2020

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations are made under the Teaching and Higher Education Act 1998 ("the 1998 Act") and they amend—

- (a) The Education (Student Support) (Wales) Regulations 2017 ("the 2017 Regulations"), and
- (b) The Education (Student Support) (Wales) Regulations 2018 ("the 2018 Regulations").

The 2017 Regulations provide for financial support for eligible students taking designated higher education courses which begin before 1 September 2018. Part 2 of these Regulations amends regulation 62 of the 2017 Regulations which concerns, amongst other things, the recovery by the Welsh Ministers of overpayments of loans for living costs. The way in which the Welsh Ministers may recover such overpayments no longer depends on whether a student has failed to provide information or has provided inaccurate information. Regulation 62 also enables the Welsh Ministers to require a student to repay an overpayment in accordance with regulations made under section 22 of the 1998 Act.

The 2018 Regulations provide for financial support for eligible students taking designated higher education courses which begin on or after 1 September 2018. Part 3 of these Regulations amends the 2018 Regulations.

Mae rheoliad 5 yn diwygio rheoliad 19 (terfynu cymhwystra yn gynnar) fel y bydd myfyriwr sy'n ymgymryd â chwrs dysgu o bell y tu allan i'r Deyrnas Unedig am reswm sy'n ymwneud â'r coronafeirws yn parhau i fod yn gymwys i gael cyllid.

Mae rheoliad 6 yn diwygio rheoliad 39 (amodau cymhwysyo i gael benthyciad at ffioedd dysgu) i ddileu'r gofyniad i fyfyriwr sy'n ymgymryd â chwrs dysgu o bell fod yng Nghymru ar ddiwrnod cyntaf y cwrs hwnnw, mewn achosion pan fo'r absenoldeb yn ymwneud â'r coronafeirws.

Mae rheoliad 7 yn diwygio rheoliad 44 (amodau cymhwysyo i gael y grant sylfaenol a'r grant cynhaliaeth) i ddileu'r gofyniad i fyfyriwr sy'n ymgymryd â chwrs dysgu o bell fod yng Nghymru ar ddiwrnod cyntaf y cwrs hwnnw, mewn achosion pan fo'r absenoldeb yn ymwneud â'r coronafeirws.

Mae rheoliad 8 yn diwygio rheoliad 54 (amodau cymhwysyo i gael benthyciad cynhaliaeth) i ddileu'r gofyniad i fyfyriwr sy'n ymgymryd â chwrs dysgu o bell fod yng Nghymru ar ddiwrnod cyntaf y cwrs hwnnw, mewn achosion pan fo'r absenoldeb yn ymwneud â'r coronafeirws.

Mae rheoliad 9 yn diwygio rheoliad 62 (amodau cymhwysyo i gael grant myfyriwr anabl) i ddileu'r gofyniad i fyfyriwr sy'n ymgymryd â chwrs dysgu o bell fod yng Nghymru ar ddiwrnod cyntaf y cwrs hwnnw, mewn achosion pan fo'r absenoldeb yn ymwneud â'r coronafeirws.

Mae rheoliad 10 yn rhoi rheoliad 91 newydd (adenill benthyciadau cynhaliaeth sydd wedi cael eu gordalu) yn Rheoliadau 2018 yn lle'r un presennol. Nid yw'r ffordd y caiff Gweinidogion Cymru adenill gordaliadau o'r fath yn dibynnu mwyach ar ba un a yw myfyriwr wedi methu â darparu gwybodaeth neu wedi darparu gwybodaeth anghywir. Mae rheoliad 91 hefyd yn galluogi Gweinidogion Cymru i'w gwneud yn ofynnol i fyfyriwr ad-dalu gordaliad yn unol â rheoliadau a wneir o dan adran 22 o Ddeddf 1998.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. Gellir cael copi oddi wrth: yr Is-adran Addysg Uwch, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

Regulation 5 amends regulation 19 (early termination of eligibility) so that a student undertaking a distance learning course outside the United Kingdom for a reason related to coronavirus will remain eligible for funding.

Regulation 6 amends regulation 39 (qualifying conditions for tuition fee loan) to remove the requirement for a student undertaking a distance learning course to be in Wales on the first day of that course, in cases where the absence relates to coronavirus.

Regulation 7 amends regulation 44 (qualifying conditions for base grant and maintenance grant) to remove the requirement for a student undertaking a distance learning course to be in Wales on the first day of that course, in cases where the absence relates to coronavirus.

Regulation 8 amends regulation 54 (qualifying conditions for maintenance loan) to remove the requirement for a student undertaking a distance learning course to be in Wales on the first day of that course, in cases where the absence relates to coronavirus.

Regulation 9 amends regulation 62 (qualifying conditions for disabled student's grant) to remove the requirement for a student undertaking a distance learning course to be in Wales on the first day of that course, in cases where the absence relates to coronavirus.

Regulation 10 substitutes a new regulation 91 (recovery of overpayments of maintenance loans) into the 2018 Regulations. The way in which the Welsh Ministers may recover such overpayments no longer depends on whether a student has failed to provide information or has provided inaccurate information. Regulation 91 also enables the Welsh Ministers to require a student to repay an overpayment in accordance with regulations made under section 22 of the 1998 Act.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers, in exercise of the powers conferred on the Secretary of State by sections 22(2)(a), (e) and (g) and 42(6) of the Teaching and Higher Education Act 1998(1) and now exercisable by them(2), make the following Regulations:

(2) Trosglwyddwyd swyddogaethau'r Ysgrifennydd Gwladol yn adran 22(2)(a) i (i) a (k) o Ddeddf Addysgu ac Addysg Uwch 1998 i Gynulliad Cenedlaethol Cymru i'r graddau y maent yn ymwneud â gwneud darpariaeth o ran Cymru gan adran 44 o Ddeddf Addysg Uwch 2004 (p. 8), ac mae is-adran (2)(a), (c) a (k) yn arferadwy yn gydredol â'r Ysgrifennydd Gwladol. Trosglwyddwyd swyddogaeth yr Ysgrifennydd Gwladol yn adran 42, i'r graddau y mae'n arferadwy o ran Cymru, i Gynulliad Cenedlaethol Cymru gan O.S. 1999/672. Trosglwyddwyd holl swyddogaethau Cynulliad Cenedlaethol Cymru uchod i Weinidogion Cymru yn rhinwedd paragraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006 (p. 32).

All the above functions of the National Assembly for Wales were transferred to the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006 (c. 32).

PART 1

TITLE, COMMENCEMENT AND APPLICATION

Title, commencement and application

1.—(1) The title of these Regulations is the Education (Student Support) (Miscellaneous Amendments) (Wales) (No. 2) Regulations 2020.

(2) These Regulations come into force on 31 July 2020 and apply to the provision of support to students in relation to an academic year which begins on or after 1 August 2020.

PART 2

AMENDMENTS TO THE EDUCATION (STUDENT SUPPORT) (WALES) REGULATIONS 2017

Amendments to the Education (Student Support) (Wales) Regulations 2017

2. The Education (Student Support) (Wales) Regulations 2017(1) are amended in accordance with regulation 3.

Amendments to regulation 62

3. In regulation 62—

(a) for paragraph (10) substitute—

“(10) Any overpayment of a loan for living costs in respect of any academic year may be recovered by the Welsh Ministers—

(a) by subtracting the overpayment from the amount of any loan payable to the student from time to time under these Regulations or any other regulations made by the Welsh Ministers under section 22 of the 1998 Act;

(b) by requiring the student to repay the overpayment in accordance with regulations made under section 22 of the 1998 Act;

- (b) na fo M yn gallu bod yng Nghymru ar ddiwrnod cyntaf blwyddyn academaidd gyntaf y cwrs am reswm sy'n ymwneud â'r coronafeirws."

Amnewid rheoliad 91

10. Yn lle rheoliad 91 rhodder—

“91. Pan fo benthyciad cynhaliaeth wedi cael ei ordalu caiff Gweinidogion Cymru adennill y gordaliad—

- (a) drwy ddidynnu'r gordaliad o unrhyw fenthyciad cynhaliaeth sy'n daladwy i'r myfyriwr cymwys o bryd i'w gilydd o dan y Rheoliadau hyn neu unrhyw reoliadau eraill a wneir gan Weinidogion Cymru o dan adran 22 o Ddeddf 1998;
- (b) drwy ei gwneud yn ofynnol i'r myfyriwr cymwys ad-dalu'r gordaliad yn unol â rheoliadau a wneir o dan adran 22 o Ddeddf 1998;
- (c) drwy unrhyw ddull arall sydd ar gael iddynt.”

Diwygiad i Atodlen 1

11. Yn Atodlen 1, ym mharagraff 6(1), yn y lle priodol mewnosoder—

“ystyr “coronafeirws” (“coronavirus”) yw coronafeirws syndrom anadol aciwt difrifol 2 (SARS-CoV-2);”.

But this exception does not apply where—

- (a) S is not in Wales on the first day of the first academic year of the course because S, or a close relative of S, is serving as a member of the armed forces outside Wales, or
- (b) S is unable to be in Wales on the first day of the first academic year of the course for a reason related to coronavirus.”

Substitution of regulation 91

10. For regulation 91 substitute—

“91. Where a maintenance loan has been overpaid the Welsh Ministers may recover the overpayment—

- (a) by subtracting it from any maintenance loan payable to the eligible student from time to time under these Regulations or any other regulations made by the Welsh Ministers under section 22 of the 1998 Act;
- (b) by requiring the eligible student to repay the overpayment in accordance with regulations made under section 22 of the 1998 Act;
- (c) by any other method available to them.
”

Amendment to Schedule 1

11. In Schedule 1, in paragraph 6(1), at the appropriate place insert—

““coronavirus” (“coronafeirws”) means severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);”.
