Mae'r Gorchymyn hwn yn cynyddu uchafswm treuliau etholiad ymgeiswyr mewn etholiadau llywodraeth leol yng Nghymru. Mae'r cynnydd yn adlewyrchu chwyddiant ers i'r uchafswm gael ei amrywio ddiwethaf gan Orchymyn Cynrychiolaeth y Bobl (Amrywio Terfynau Treuliau Etholiad Ymgeiswyr) 2014 (O.S. 2014/1870).

Mae uchafswm treuliau etholiad ymgeiswyr yn cynnwys swm penodedig (a fynegir mewn punnoedd) plws swm (a fynegir mewn ceiniogau) ar gyfer pob cofnod yn y gofrestr etholwyr.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order increases the maximum amount of candidates' election expenses at local government elections in Wales. The increase reflects inflation since the maximum amount was last varied by the Representation of the People (Variation of Limits of Candidates' Election Expenses) Order 2014 (S.I. 2014/1870).

The maximum amount of candidates' election expenses consists of a fixed amount (expressed in pounds) plus a sum (expressed in pence) for each entry in the register of electors.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The Welsh Ministers, in exercise of the power conferred on them by section 76A(1)(a) of the Representation of the People Act 1983(1), and considering it expedient in consequence of changes in the value of money, make the following Order(2):

**Title and commencement**

1. The title of this Order is the Representation of the People (Variation of Limits of Candidates' Election Expenses) (Wales) Order 2021 and it comes into force on 1 January 2022.

2. Yn adran 76(2)(b) o Ddeddf Cynrychiolaeth y Bobl 1983(1) (uchafswm treuliau ymgeisydd mewn etholiad llywodraeth leol ac eithrio etholiad o dan Ddeddf Awdurdod Llundain Fwyaf 1999(2)), o flaen is-baragraff (ii) mewnosoder—

“(ic) at a local government election in Wales, £806 together with an additional 7p for every entry in the register of electors;”.

## Variation of expenses limit at a local government election in Wales

2. In section 76(2)(b) of the Representation of the People Act 1983(1) (maximum amount of a candidate’s expenses at a local government election other than an election under the Greater London Authority Act 1999(2)), before sub-paragraph (ii) insert—

“(ic) at a local government election in Wales, £806 together with an additional 7p for every entry in the register of electors;”.
