Mae'r Rheoliadau hyn yn diwygio Rheoliadau Ffedereiddio Ysgolion a Gynhelir (Cymru) 2014 (O.S. 2014/1132 (Cy. 111)).

Mae'r Rheoliadau hyn yn darparu, ar gyfer ffederasiynau sy'n cynnwys dwy ysgol yn unig, y caniateir i berson gael ei ethol yn athro-lywodraethwr neu'n staff-lywodraethwr er ei fod yn gweithio yn yr un ysgol ffederal ag athro-lywodraethwr neu staff-lywodraethwr blaenorol a wasanaethodd yn ystod y ddwy flynedd ddiwethaf.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

#### EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend the Federation of Maintained Schools (Wales) Regulations 2014 (S.I. 2014/1132 (W. 111)).

These Regulations provide that for federations consisting of only two schools, a person may be elected as a teacher or staff governor despite working at the same federated school as a previous teacher or staff governor who served within the past two years.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers, in exercise of the powers conferred on them by sections 19(3) and (9) and 210(7) of the Education Act 2002(1), and now vested in them(2), make the following Regulations:

**Title and commencement**

1.—(1) The title of these Regulations is the Federation of Maintained Schools (Wales) (Amendment) Regulations 2021.

(2) These Regulations come into force on 4 February 2022.

**Amendments to the Federation of Maintained  
Schools (Wales) Regulations 2014**

2.—(1) The Federation of Maintained Schools (Wales) Regulations 2014(3) are amended as follows.

(2) In regulation 15 (teacher governors), in paragraph (4)—


