ROAD TRAFFIC, WALES

The A4042 Trunk Road (Caerleon Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2021

Made 5 March 2021

Coming into force 7 March 2021

The Welsh Ministers, as traffic authority for the relevant length of the A4042 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A4042 Trunk Road (Caerleon Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2021 and it comes into force on 7 March 2021.

2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the trunk road" ("y gefnffordd") means the A4042 Newport to Shrewsbury trunk road;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 20:00 hours on 7 March 2021 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibition

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

SCHEDULE

The length of the westbound carriageway of the trunk road that extends from its junction with the western side of Caerleon Roundabout to the nosing of the M4 Junction 25A westbound exit slip road.

The length of the eastbound carriageway of the trunk road that extends from its junction with the eastern side of Grove Park Roundabout to its junction with the western side of Caerleon Roundabout, Newport.

The length of the trunk road that extends from its junction with the northern side of Grove Park Roundabout, Newport to its junction with the southern side of Croes-y-Mwyalch Roundabout, Torfaen.

The length of the trunk road that extends from its junction with the northern side of Croes-y-Mwyalch

Roundabout to its junction with the southern side of Crown Roundabout, Torfaen.

The length of the trunk road that extends from its junction with the northern side of Crown Roundabout to its junction with the southern side of Turnpike Roundabout, Torfaen.

The length of the trunk road that extends from its junction with the northern side of Turnpike Roundabout to its junction with the southern side of Edlogan Way Roundabout, Torfaen.

The length of the trunk road that extends from its junction with the northern side of Edlogan Way Roundabout to its junction with the southern side of Cwmbran Roundabout, Torfaen.
