This Order appoints 9 March 2021 as the day on which the Candidate Election Expenses (Senedd Elections) Code of Practice 2021 ("the Code of Practice") comes into force.

The Electoral Commission prepared the Code of Practice and submitted it to the Welsh Ministers for approval. The Welsh Ministers have approved the Code of Practice, which was laid before Senedd Cymru on 20 January 2021.

The Senedd did not resolve not to approve the Code of Practice and as a result, the Welsh Ministers make this Order issuing the Code of Practice, as it was laid before the Senedd.

The Welsh Ministers, in exercise of the powers conferred by paragraph 14(7)(b) of Schedule 7 to the National Assembly for Wales (Representation of the People) Order 2007(1) ("the 2007 Order") make the following Order.

Mae'r Comisiwn Etholiadol wedi llunio Cod Ymarfer drafft ac yn unol â pharagraff 14(2) o Atodlen 7 i Orchymyn 2007 wedi ei gyflwyno i Weinidogion Cymru i'w gymeradwyo ganddynt.

The Electoral Commission have prepared a draft Code of Practice and in accordance with paragraph 14(2) of Schedule 7 to the 2007 Order have submitted it to the Welsh Ministers for approval.

Mae Gweinidogion Cymru wedi cymeradwyo'r Cod Ymarfer drafft ac yn unol â pharagraff 14(4) o Atodlen 7 i Orchymyn 2007, gosodwyd drafft o God Ymarfer Treuliau Etholiad Ymgeiswyr (Etholiadau'r Senedd) 2021 gerbron Senedd Cymru ar 20 Ionawr 2021.

The Welsh Ministers have approved the draft Code of Practice and in accordance with paragraph 14(4) of Schedule 7 to the 2007 Order, a draft of the Candidate Election Expenses (Senedd Elections) Code of Practice 2021 was laid before Senedd Cymru on 20 January 2021.

Yn unol â pharagraff 14(6) o Atodlen 7 i Orchymyn 2007, o fewn cyfnod o 40 niwrnod, ni phenderfynodd Senedd Cymru beidio â chymeradwyo Cod Ymarfer drafft Treuliau Etholiad Ymgeiswyr (Etholiadau'r Senedd) 2021, a dyroddwyd y Cod ar ffurf y drafft.
