Mae'r Gorchymyn hwn yn diwygio adran 101(3)(b) o Ddeddf Tai (Cymru) 2014 ("y Ddeddf").

This Order amends section 101(3)(b) of the Housing (Wales) Act 2014 ("the Act").

Mae adran 101 o'r Ddeddf yn gwneud darpariaeth ar gyfer cynnal asesiad gan awdurdod tai lleol o anghenion llety Sipsiwn a Theithwyr sy'n preswyllo yn ei ardal neu sy'n cyrchu yno. Mae adran 101(3) o'r Ddeddf yn nodi ystyr y "cyfnod adolygu", sef y cyfnod y mae rhaid i'r asesiad hwn gael ei gynnal ynddo.

Section 101 of the Act makes provision for the assessment of accommodation needs by a local housing authority of Gypsies and Travellers residing in or resorting to its area. Section 101(3) of the Act sets out the meaning of the "review period", which is the period during which this assessment must be carried out.

Y cyfnod adolygu cyntaf o dan adran 101(3)(a) oedd y cyfnod o 25 Chwefror 2015 i 24 Chwefror 2016. O dan adran 101(3)(b) roedd pob asesiad dilynol i'w gynnal yn ystod pob cyfnod dilynol o 5 mlynedd. Oherwydd effeithiau'r coronafeirws ar gymunedau yng Nghymru a'i effaith ar weinyddu mewn awdurdodau tai lleol mae'r cyfnod adolygu, a fyddai fel arall wedi dod i ben ar 24 Chwefror 2021, wedi ei estyn gan un flwyddyn.

The first review period under section 101(3)(a) was the period from 25 February 2015 to 24 February 2016. Under section 101(3)(b) all subsequent assessments were to take place during each subsequent period of 5 years. Due to the impacts of coronavirus on communities in Wales and the effect that it has had on administration within local housing authorities the review period, which otherwise would have come to an end on 24 February 2021, is extended by one year.

Mae'r Gorchymyn hwn yn diwygio ystyr "cyfnod adolygu" yn adran 101(3) o'r Ddeddf fel bod y cyfnod adolygu sy'n dilyn y cyfnod adolygu o dan baragraff (a) wedi ei gynyddu o 5 i 6 mlynedd. Ar ôl hynny, y cyfnod adolygu yw 5 mlynedd.

This Order amends the meaning of "review period" in section 101(3) of the Act so that the review period following the review period under paragraph (a) is increased from 5 to 6 years. Thereafter, the review period is 5 years.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, lluniwyd aseiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn. The Welsh Ministers make the following Order in exercise of the power conferred on them by section 101(4) of the Housing (Wales) Act 2014(1).

In accordance with section 142(3)(c) of that Act, a draft of this Order has been laid before, and approved by a resolution of, Senedd Cymru(2).

**Title and commencement**

**1.**—(1) The title of this Order is the Assessment of Accommodation Needs of Gypsies and Travellers (Extension of Review Period) (Wales) (Coronavirus) Order 2021.

(2) This Order comes into force on 18 March 2021.

**Amendment to section 101(3) of the Housing  
(Wales) Act 2014**

**2.**—(1) Section 101(3) of the Housing (Wales) Act 2014 is amended as follows.

(2) The reference in section 142(3) to the National Assembly for Wales now has effect as a reference to Senedd Cymru, by virtue of section 150A(2) of the Government of Wales Act 2006 (c. 32).

(2) Yn lle paragraff (b) rhodder—

“(b) y cyfnod o 6 mlynedd sy’n dechrau â thrannoeth y diwrnod y daeth y cyfnod ym mharagraff (a) i ben, a phob cyfnod dilynol o 5 mlynedd sy’n dechrau â thrannoeth y diwrnod y daeth y cyfnod adolygu blaenorol i ben.”

(2) For paragraph (b) substitute—

“(b) the period of 6 years beginning with the day after the period in paragraph (a) ended, and each subsequent period of 5 years beginning with the day after the previous review period ended.”
