Mae Rhan 2A o Ddeddf Iechyd y Cyhoedd (Rheoli Clefydau) 1984 yn galluogi Gweinidogion Cymru, drwy reoliadau, i wneud darpariaeth at ddiben atal, diogelu rhag, rheoli neu ddarparu ymateb iechyd y cyhoedd i fynychder neu ledaeniaid haint neu halogiad yng Nghymru.

Mae'r Rheoliadau hyn wedi eu gwneud mewn ymateb i'r bygythiad difrifol ac uniongyrchol i iechyd y cyhoedd a berir gan fynychder a lledaeniaid coronafeirws syndrom anadolol acíwt difrifol 2 (SARS-CoV-2) yng Nghymru.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Diogelu Iechyd (Cyfyngiadau Coronafeirws) (Rhif 5) (Cymru) 2020 (O.S. 2020/1609 (Cy. 335)) ("y prif Reoliadau").

Mae'r diwygiadau yn darparu, o 3 Mai 2021, fod Cymru gyfan ar Lefel Rhybudd 3 yn llawn a bod y cyfyngiadau a'r gofynion a nodir yn Atodlen 3 i'r prif Reoliadau yn gymwys. Mae'r cyfyngiadau a'r gofynion dros dro (trosiannol) a nodir yn Atodlen 3A, sydd wedi bod yn gymwys i Gymru gyfan ers 27 Mawrth 2021, wedi eu dirymu.

The Health Protection (Coronavirus

2021

EXPLANATORY NOTE

(This note is not part of the Regulations)

Part 2A of the Public Health (Control of Disease) Act 1984 enables the Welsh Ministers, by regulations, to make provision for the purpose of preventing, protecting against, controlling or providing a public health response to the incidence or spread of infection or contamination in Wales.

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales.

These Regulations amend the Health Protection (Coronavirus Restrictions) (No. 5) (Wales) Regulations 2020 (S.I. 2020/1609 (W. 335)) ("the principal Regulations").

The amendments provide that from 3 May 2021 the whole of Wales is fully at Alert Level 3 and the restrictions and requirements set out in Schedule 3 to the principal Regulations apply. The temporary (transitional) restrictions and requirements set out in Schedule 3A, which have applied to the whole of Wales since 27 March 2021, are revoked.

Mae symud i gyfyngiadau Lefel Rhybudd 3 llawn Atodlen 3 yn golygu, o 3 Mai 2021—

- y caiff unrhyw aelwyd gytuno i gael ei thrin fel aelwyd estynedig ag un aelwyd arall (ac â'r aelwyd honno yn unig), neu â dwy aelwyd arall os yw un o'r aelwydydd yn aelwyd anghenion llesiant;
- y caniateir gweithgareddau wedi eu trefnu o dan do ar gyfer grwpiau o hyd at 15 o bobl, heb gyfrif personau o dan 11 oed;
- y caniateir i weithgareddau wedi eu trefnu er datblygiad neu lesiant plant gael eu cynnal o dan do hefyd;
- y caniateir i ganolfannau cymunedol agor eu mangreodd o dan do hefyd;
- y caniateir i gyfleusterau chwaraeon ac ymarfer corff o dan do agor.

Mae'r Rheoliadau yn diwygio Atodlen 3 i ganiatáu i sbaon agor o dan y cyfyngiadau Lefel Rhybudd 3 (ond mae'n ofynnol i ystafelloedd stêm aros ar gau).

Mae'r Rheoliadau hefyd yn cywiro mân wall a wnaed wrth ddiwygio paragraff 2(6)(k) o Atodlen 2 i'r prif Reoliadau gan Reoliadau Diogelu Iechyd (Cyfyngiadau Coronafeirws) (Rhif 5) (Cymru) (Diwygio) (Rhif 8) 2021 (O.S. 2021/502 (Cy. 150)) ac yn gwneud diwygiad canlyniadol i Reoliadau Diogelu Iechyd (Cyfyngiadau Coronafeirws) (Swyddogaethau Awdurdodau Lleol etc.) (Cymru) 2020 (O.S. 2020/1011 (Cy. 225)).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ni luniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The move to the full Alert Level 3 restrictions in Schedule 3 means that from 3 May 2021—

- any household may agree to be treated as an (exclusive) extended household with one other household, or with two other households if one of the households is a well-being needs household;
- indoor organised activities are allowed for groups of up to 15 people, not counting persons under the age of 11;
- organised activities for the development or well-being of children may also be held indoors;
- community centres are allowed to also open their indoor premises;
- indoor sports and exercise facilities are allowed to open.

The Regulations amend Schedule 3 to allow spas to open under the Alert Level 3 restrictions (but steam rooms are required to remain closed).

The Regulations also correct a minor error made in the amendment of paragraph 2(6)(k) of Schedule 2 to the principal Regulations by the Health Protection (Coronavirus Restrictions) (No. 5) (Wales) (Amendment) (No. 8) Regulations 2021 (S.I. 2021/502 (W. 150)) and make a consequential amendment to the Health Protection (Coronavirus Restrictions) (Functions of Local Authorities etc.) (Wales) Regulations 2020 (S.I. 2020/1011 (W. 225)).

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has not been prepared as to the likely cost and benefit of complying with these Regulations.

PUBLIC HEALTH, WALES

The Health Protection (Coronavirus Restrictions) (No. 5) (Wales) (Amendment) (No. 9) Regulations 2021

Approved by Senedd Cymru

Made 29 April 2021

Coming into force 3 May 2021

To be laid before Senedd Cymru

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 45C(1) and (3)(c), 45F(2) and 45P(2) of the Public Health (Control of Disease) Act 1984(1).

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Wales.

The Welsh Ministers consider that restrictions and requirements imposed by these Regulations are proportionate to what they seek to achieve, which is a public health response to that threat.

In accordance with section 45R of that Act the Welsh Ministers are of the opinion that, by reason of urgency, it is necessary to make this instrument without a draft having been laid before, and approved by a resolution of, Senedd Cymru.

Title and coming into force

1.—(1) The title of these Regulations is the Health Protection (Coronavirus Restrictions) (No. 5) (Wales) (Amendment) (No. 9) Regulations 2021.

(2) These Regulations come into force immediately before the start of the day on 3 May 2021.
