Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn ac maent yn dwyn i rym ddarpariaethau Deddf Amaethyddiaeth 2020 (p. 21) ("y Ddeddf").

These Regulations are made by the Welsh Ministers and bring into force provisions of the Agriculture Act 2020 (c. 21) ("the Act").

Mae Rheoliad 2(a) yn dwyn i rym, ar 13 Rhagfyr 2022, Ran 4 o Atodlen 7 i'r Ddeddf. Mae Rheoliad 2(b) yn dwyn i rym, ar 13 Rhagfyr 2022, adran 52 o'r Ddeddf i'r graddau y mae'n ymwneud â'r Rhan honno.

Regulation 2(a) brings into force, on 13 December 2022, Part 4 of Schedule 7 to the Act. Regulation 2(b) brings into force, on 13 December 2022, section 52 of the Act so far as relating to that Part.

O ganlyniad i'r ddarpariaeth yn Rhan 4 o Atodlen 5 i'r Ddeddf, mae Rhan 4 o Atodlen 7 i'r Ddeddf yn gwneud diwygiadau canlyniadol yng Nghymru mewn perthynas â darpariaethau safonau marchnata a dosbarthu carcasau yn Rheoliad (EU) Rhif 1308/2013 Senedd Ewrop a'r Cyngor dyddiedig 17 Rhagfyr 2013 gan sefydlu cyd-drefniadaeth y marchnadoedd mewn cynhyrchion amaethyddol ("y Rheoliad CMO").

As a consequence of the provision in Part 4 of Schedule 5 to the Act, Part 4 of Schedule 7 to the Act makes consequential amendments in Wales in relation to marketing standards and carcass classification provisions in Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products ("the CMO Regulation").
