Mae'r Rheoliadau hyn wedi eu gwneud o dan y pŵer sydd wedi ei gynnwys yn Erthygl 25(b) o Reoliad (EU) Rhif 1308/2013 Senedd Ewrop a'r Cyngor sy'n sefydlu cyd-drefniadaeth y marchnadoedd mewn cynhyrchion amaethyddol ("y Rheoliad CMO"), fel y'i darllenir gydag Erthygl 3(5)(c)(i)(bb) o'r Rheoliad hwnnw. Maent yn gymwys yng Nghymru yn unig.

Mae'r Rheoliadau hyn yn diwygio Erthyglau 4 a 9 o Reoliad Gweithredu'r Comisiwn (EU) 2017/39. Maent yn diwygio darpariaethau sy'n ymwneud â thystiolaeth ddogfennol sy'n ategu ceisiadau am gymorth o dan y cynllun a sefydlwyd gan Erthyglau 22 i 25 o'r Rheoliad CMO. O ganlyniad i'r diwygiadau hyn, rhaid nad yw ymgeiswyr ond yn dal y dystiolaeth ddogfennol honno sydd ar gael i'r awdurdod perthnasol. Yn flaenorol, roedd rhaid iddynt gyflwyno dystiolaeth ddogfennol ategol gyda'r cais am gymorth.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made under the power contained in Article 25(b) of Regulation (EU) No 1308/2013 of the European Parliament and of the Council establishing a common organisation of the markets in agricultural products ("the CMO Regulation"), as read with Article 3(5)(c)(i)(bb) of that Regulation. They apply only in Wales.

These Regulations amend Articles 4 and 9 of Commission Implementing Regulation (EU) 2017/39. They amend provisions relating to documentary evidence supporting applications for aid under the scheme established by Articles 22 to 25 of the CMO Regulation. As a result of these amendments, applicants must only hold such documentary evidence available for the relevant authority. Previously, they had to submit supporting documentary evidence with the application for aid.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pŵer a roddir gan Erthygl 25(b) o Reoliad (EU) Rhif 1308/2013 Senedd Ewrop a'r Cyngor sy'n sefydlu cyd-drefniadaeth y marchnadoedd mewn cynhyrchion amaethyddol(1), fel y'i darllenir gydag Erthygl 3(5)(c)(i)(bb) o'r Rheoliad hwnnw(2).

The Welsh Ministers make these Regulations in exercise of the power conferred by Article 25(b) of Regulation (EU) No 1308/2013 of the European Parliament and of the Council establishing a common organisation of the markets in agricultural products(1), as read with Article 3(5)(c)(i)(bb) of that Regulation(2).

Cynhaliwyd ymgynghoriad fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(3).

There has been consultation as required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(3).

Title, commencement and application

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Ceisiadau am Gymorth Llaeth a Chynhyrchion Llaeth (Disgyblion mewn Sefydliadau Addysgol) (Cymru) 2022.

1.—(1) The title of these Regulations is the Milk and Milk Products (Pupils in Educational Establishments) Aid Applications (Wales) Regulations 2022.

(2) Daw'r Rheoliadau hyn i rym ar 9 Mawrth 2022.

(2) These Regulations come into force on 9 March 2022.

2.—(1) Mae Rheoliad Gweithredu'r Comisiwn (EU) 2017/39 ar reolau ar gyfer cymhwyso Rheoliad (EU) Rhif 1308/2013 Senedd Ewrop a'r Cyngor o ran cymorth Undeb ar gyfer cyflenwi ffrwythau a llysiau, bananas a llaeth mewn sefydliadau addysgol(1) wedi ei ddiwygio fel a ganlyn.

(2) Yn Erthygl 4(2), ym mharagraff 6—

- (a) ar ôl “evidence” yn y lle cyntaf y mae'n ymddangos, mewnosoder “held available for the relevant authority”,
- (b) hepgorer y geiriau o “The relevant authority shall specify” hyd at “aid applications.”

(3) Yn Erthygl 9(3), hepgorer paragraff 2.

Amendment of Commission Implementing Regulation (EU) 2017/39 in respect of Wales

2.—(1) Commission Implementing Regulation (EU) 2017/39 on rules for the application of Regulation (EU) No 1308/2013 of the European Parliament and of the Council with regard to Union aid for the supply of fruit and vegetables, bananas and milk in educational establishments(1) is amended as follows.

(2) In Article 4(2), in paragraph 6—

- (a) after “evidence” where it first appears, insert “held available for the relevant authority”,
- (b) omit the words from “The relevant authority shall specify” to “aid applications.”

(3) In Article 9(3), omit paragraph 2.
