Mae'r Rheoliadau hyn yn diwygio Rheoliadau Bwydydd Proses sydd wedi'u Seilio ar Rawn a Bwydydd Babanod ar gyfer Babanod a Phlant Ifanc (Cymru) 2004 (O.S. 2004/314 (Cy. 32)) ("Rheoliadau 2004"), sy'n gwahardd gwerthu bwydydd proses sydd wedi eu seilio ar rawn a bwydydd babanod ar gyfer babanod a phlant ifanc, oni bai eu bod yn cydymffurfio â'r gofynion o ran gweithgynhyrchu, cyfansoddiad a labelu a nodir yn y Rheoliadau hynny.

These Regulations amend the Processed Cereal-based Foods and Baby Foods for Infants and Young Children (Wales) Regulations 2004 (S.I. 2004/314 (W. 32)) ("the 2004 Regulations"), which prohibit the sale of processed cereal-based foods and baby foods for infants and young children, unless they comply with the manufacturing, compositional and labelling requirements set out in those Regulations.

Mae rheoliad 2 o'r Rheoliadau hyn yn diwygio Atodlen 4 i Reoliadau 2004 i ganiatáu ychwanegu calsiwm-L-methylffolad, bisglycinad fferrus a zinc clorid wrth weithgynhyrchu bwydydd proses sydd wedi eu seilio ar rawn a bwydydd babanod. Mae'r diwygiadau i Atodlen 4 hefyd yn dod â'r sylweddau maethol hynny o fewn cwmpas y gofynion labelu a nodir yn rheoliad 8(2) a (3) o Reoliadau 2004.

Regulation 2 of these Regulations amends Schedule 4 to the 2004 Regulations to permit the addition of calcium-L-methylfolate, ferrous bisglycinate and zinc chloride in the manufacture of processed cereal-based foods and baby foods. The amendments to Schedule 4 also bring those nutritional substances within the scope of the labelling requirements set out in regulation 8(2) and (3) of the 2004 Regulations.

Ystyriwyd cod ymarfer Gweinidogion Cymru ar gynnal asesiadau effaith rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

The Welsh Ministers' code of practice on the carrying out of regulatory impact assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pwerau a roddir gan adrannau 16(1)(a) ac (e) ac 48(1) o Ddeddf Diogelwch Bwyd 1990(1) ac a freiniwyd bellach ynddynt hwy(2).

The Welsh Ministers make these Regulations in exercise of the powers conferred by sections 16(1)(a) and (e) and 48(1) of the Food Safety Act 1990(1) and now vested in them(2).

Mae Gweinidogion Cymru wedi rhoi sylw i gyngor perthnasol a roddwyd gan yr Asiantaeth Safonau Bwyd yn unol ag adran 48(4A) o Ddeddf Diogelwch Bwyd 1990(3).

The Welsh Ministers have had regard to relevant advice given by the Food Standards Agency in accordance with section 48(4A) of the Food Safety Act 1990(3).

Cynhaliwyd ymgynghoriad fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion a gofynion cyffredinol cyfraith bwyd, yn sefydlu Awdurdod

There has been consultation as required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing

2.—(1) Mae Rheoliadau Bwydydd Proses sydd wedi'u Seilio ar Rawn a Bwydydd Babanod ar gyfer Babanod a Phlant Ifanc (Cymru) 2004(2) wedi eu diwygio fel a ganlyn.

(2) Yn Atodlen 4 (sylweddau maethol)—

- (a) ym mharagraff 1 (fitaminau) ar ôl “Asid ffolig” mewnosoder “Calsiwm-L-methylffolad”; a
- (b) ym mharagraff 4 (halwynau mwynau ac elfennau hybrin)—
  - (i) ar ôl “Carbonad fferrus” mewnosoder “Bisglycinad fferrus”; a
  - (ii) ar ôl “Zinc asetad” mewnosoder “Zinc clorid”.

## Title and commencement

1.—(1) The title of these Regulations is the Processed Cereal-based Foods and Baby Foods for Infants and Young Children (Wales) (Amendment) Regulations 2022.

(2) These Regulations come into force on 18 January 2023.

## Amendments to the Processed Cereal-based Foods and Baby Foods for Infants and Young Children (Wales) Regulations 2004

2.—(1) The Processed Cereal-based Foods and Baby Foods for Infants and Young Children (Wales) Regulations 2004(2) are amended as follows.

(2) In Schedule 4 (nutritional substances)—

- (a) in paragraph 1 (vitamins) after “Folic acid” insert “Calcium-L-methylfolate”; and
- (b) in paragraph 4 (salts of minerals and trace elements)—
  - (i) after “Ferrous carbonate” insert “Ferrous bisglycinate”; and
  - (ii) after “Zinc acetate” insert “Zinc chloride”.
