EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cyd-bwyllgor Corfforedig De-ddwyrain (Cymru) 2021 ("Rheoliadau Sefydlu'r De-ddwyrain"), i ohirio'r dyddiad y bydd swyddogaethau penodol yn cael eu rhoi i Gyd-bwyllgor Corfforedig y De-ddwyrain.

These Regulations amend the South East Wales Corporate Joint Committee Regulations 2021 ("the South East Wales Establishment Regulations"), to postpone the date on which certain functions will be conferred on the South East Wales Corporate Joint Committee.

Gwnaed Rheoliadau Sefydlu'r De-ddwyrain o dan Ran 5 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 ("Deddf 2021"), a sefydlwyd Cyd-bwyllgor Corfforedig y De-ddwyrain ganddynt.

The South East Wales Establishment Regulations were made under Part 5 of the Local Government and Elections (Wales) Act 2021 ("the 2021 Act") and established the South East Wales Corporate Joint Committee.

Rhoddodd Rheoliadau Sefydlu'r De-ddwyrain hefyd y swyddogaethau a ganlyn i Gyd-bwyllgor Corfforedig y De-ddwyrain gydag effaith o 28 Chwefror 2022 (1 Ebrill 2021 yw dyddiad cychwyn y rhan fwyaf o weddill y Rheoliadau hynny)—

The South East Wales Establishment Regulations also conferred the following functions on the South East Wales Corporate Joint Committee with effect from 28 February 2022 (the commencement date for most of the remainder of those Regulations being 1 April 2021)—

- y swyddogaeth llesiant economaidd (o ran hynny, gweler adran 76 o Ddeddf 2021);
- datblygu polisiau trafniadaeth o dan Ran 2 o Ddeddf Trafniadaeth 2000;
- llunio cynllun datblygu strategol (o ran hynny, gweler Rhan 6 o Ddeddf Cynllunio a Phrynu Gorfodol 2004).

- the economic well-being function (as to which, see section 76 of the 2021 Act);
- developing transport policies under Part 2 of the Transport Act 2000;
- the preparation of a strategic development plan (as to which, see Part 6 of the Planning and Compulsory Purchase Act 2004).

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Sefydlu'r De-ddwyrain fel y bydd y swyddogaethau a grybwyllir uchod yn cael eu rhoi i Gyd-bwyllgor Corfforedig y De-ddwyrain gydag effaith o 30 Mehefin 2022, yn hytrach nag o 28 Chwefror 2022.

Mae'r Rheoliadau hyn hefyd yn hepgor o reoliad 1(3)(d) o Reoliadau Sefydlu'r De-ddwyrain y cyfeiriad at reoliad 11 o'r Rheoliadau hynny, o ganlyniad i amnewid rheoliad 15 o'r Rheoliadau hynny gan reoliad 36(7) o Reoliadau Cyd-bwyllgorau Corfforedig (Cyffredinol) (Rhif 2) (Cymru) 2021. Mae rheoliad 15 bellach yn cynnwys datgymhwysiad o'r pŵer i ddirprwyo swyddogaethau yn hytrach na phŵer i ddirprwyo (o ran yr olaf, gweler rheoliad 13 o Reoliadau Cyd-bwyllgorau Corfforedig (Cyffredinol) (Rhif 2) (Cymru) 2021, a ddaeth i rym ar 3 Rhagfyr 2021).

Lluniwyd asesiad effaith rheoleiddiol ar adeg gwneud Rheoliadau Sefydlu'r De-ddwyrain a gellir cael copi oddi wrth yr Is-adran Cyllid Strategol Llywodraeth Leol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

These Regulations amend the South East Wales Establishment Regulations so that the functions mentioned above will be conferred on the South East Wales Corporate Joint Committee with effect from 30 June 2022, instead of from 28 February 2022.

These Regulations also omit from regulation 1(3)(d) of the South East Wales Establishment Regulations the reference to regulation 11 of those Regulations, in consequence of the substitution of regulation 15 of those Regulations by regulation 36(7) of the Corporate Joint Committees (General) (No. 2) (Wales) Regulations 2021. Regulation 15 now contains a disapplication of the power to delegate functions rather than a power to delegate (as to the latter, see regulation 13 of the Corporate Joint Committees (General) (No. 2) (Wales) Regulations 2021, which came into force on 3 December 2021).

A regulatory impact assessment was prepared at the time of making the South East Wales Establishment Regulations and a copy can be obtained from the Local Government Strategic Finance Division, Welsh Government, Cathays Park, Cardiff, CF10 3NQ.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddir iddynt gan adrannau 80(1) a 174 o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021(1), yn gwneud y Rheoliadau a ganlyn.

The Welsh Ministers, in exercise of the powers conferred on them by sections 80(1) and 174 of the Local Government and Elections (Wales) Act 2021(1), make the following Regulations.

Yn unol ag adran 80(2)(c) ac adran 82(2) a (3)(a) a (d) o'r Ddeddf honno, mae Gweinidogion Cymru wedi ymgynghori ag unrhyw bersonau y maent yn ystyried ei bod yn briodol ymgynghori â hwy ar ddrafft o'r Rheoliadau hyn, ac wedi rhoi hysbysiad i'r prif gynghorau yn ardal Cyd-bwyllgor Corfforedig y De-ddwyrain ac i Gyd-bwyllgor Corfforedig y De-ddwyrain o'u bwriad i wneud y Rheoliadau.

In accordance with section 80(2)(c) and section 82(2) and (3)(a) and (d) of that Act, the Welsh Ministers have consulted such persons as they consider appropriate on a draft of these Regulations, and have given notice of their intention to make the Regulations to the principal councils in the area of the South East Wales Corporate Joint Committee and to the South East Wales Corporate Joint Committee.

Gosodwyd drafft o'r offeryn hwn gerbron Senedd Cymru ac fe'i cymeradwywyd ganddi drwy benderfyniad yn unol ag adran 174(4) a (5) o Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021.

A draft of this instrument has been laid before and approved by resolution of Senedd Cymru in accordance with section 174(4) and (5) of the Local Government and Elections (Wales) Act 2021.

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyd-bwyllgor Corfforedig De-ddwyrain (Cymru) (Diwygio) 2022.

(2) Daw'r Rheoliadau hyn i rym ar 18 Chwefror 2022.

Title and coming into force

1.—(1) The title of these Regulations is the South East Wales Corporate Joint Committee (Amendment) Regulations 2022.

(2) These Regulations come into force on 18 February 2022.

Diwygio Rheoliadau Cyd-bwyllgor Corfforedig De-ddwyrain (Cymru) 2021

2.—(1) Mae Rheoliadau Cyd-bwyllgor Corfforedig De-ddwyrain (Cymru) 2021(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 1(3) (cychwyn darpariaethau sy'n rhoi swyddogaethau penodol i'r cyd-bwyllgor corfforedig)—

- (a) yn lle “28 Chwefror” rhodder “30 Mehefin”, a
- (b) yn is-baragraff (d) hepgorer “11.”.

Amendment of the South East Wales Corporate Joint Committee Regulations 2021

2.—(1) The South East Wales Corporate Joint Committee Regulations 2021(1) are amended as follows.

(2) In regulation 1(3) (commencement of provisions conferring certain functions on the corporate joint committee)—

- (a) for “28 February” substitute “30 June”, and
- (b) in sub-paragraph (d) omit “11.”.
