Maent yn gwneud addasiadau i Reoliadau 2018, o ganlyniad i ddiwygiadau a wnaed gan Reoliadau Rheolaethau Swyddogol (Estyn Cyfnodau Trosiannol) (Cymru a Lloegr) (Diwygio) (Rhif 2) 2021 (O.S. 2021/1443). Gwnaeth y diwygiadau yn y Rheoliadau hynny estyn y "cyfnod graddoli trosiannol" (a ddiffiniwyd yn Atodiad 6 i Reoliad (EU) 2017/625 (EUR 2017/625)).

Mae rheoliad 2 yn diwygio Rheoliadau 2018 er mwyn alinio amseriad gosod ffioedd penodol yng Nghymru â'r cyfnod graddoli trosiannol estynedig.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenreidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made in exercise of the powers conferred by paragraph 7(2) of Schedule 4 and paragraphs 12 and 21(b) of Schedule 7 to the European Union (Withdrawal) Act 2018 (c. 16) and amend the Plant Health etc. (Fees) (Wales) Regulations 2018 (S.I. 2018/1179) (W. 238) ("the 2018 Regulations").

They make modifications to the 2018 Regulations, in consequence of amendments made by the Official Controls (Extension of Transitional Periods) (England and Wales) (Amendment) (No. 2) Regulations 2021 (S.I. 2021/1443). The amendments in those Regulations extended "the transitional staging period" (defined in Annex 6 to Regulation (EU) 2017/625 (EUR 2017/625)).

Regulation 2 amends the 2018 Regulations to align the timing of the imposition of certain fees in Wales with the extended transitional staging period.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

The Welsh Ministers make these Regulations, in exercise of the powers conferred by paragraph 7(2) of Schedule 4 and paragraphs 12 and 21(b) of Schedule 7 to the European Union (Withdrawal) Act 2018(1).

A draft of this instrument has been laid before, and approved by a resolution of, Senedd Cymru in accordance with paragraph 1(8) of Schedule 7 to that Act(2).

**Title and commencement**

1. The title of these Regulations is the Plant Health etc. (Fees) (Amendment) (Wales) (EU Exit) Regulations 2022 and they come into force on the day after the day on which they are made.

2.—(1) Mae Rheoliadau Iechyd Planhigion etc. (Ffioedd) (Cymru) 2018(1) wedi eu diwygio fel a ganlyn.

(2) Yn rheoliad 3—

(a) ym mharagraff (2E), yn lle “1 Mawrth 2022” rhodder “diwedd y cyfnod graddoli trosiannol”;

(b) ym mharagraff (3), ar ôl is-baragraff (b) mewnosoder—

“(ba) mae i “y cyfnod graddoli trosiannol” yr ystyr a roddir i “the transitional staging period” yn Atodiad 6 i Reoliad (EU) 2017/625 Senedd Ewrop a’r Cyngor ar reolaethau swyddogol a gweithgareddau swyddogol eraill a gyflawnir i sicrhau y cymhwysir cyfraith bwyd a bwyd anifeiliaid, rheolau ar iechyd a lles anifeiliaid, iechyd planhigion a chynhyrchion gwarchod planhigion.”

(3) Ym mhennawd Atodlen 2A, yn lle “1 Mawrth 2022” rhodder “ddiwedd y cyfnod graddoli trosiannol”.

**Amendment of the Plant Health etc. (Fees) (Wales) Regulations 2018**

2.—(1) The Plant Health etc. (Fees) (Wales) Regulations 2018(1) are amended as follows.

(2) In regulation 3—

(a) in paragraph (2E), for “1 March 2022” substitute “the end of the transitional staging period”;

(b) in paragraph (3), after sub-paragraph (b) insert—

“(ba) “the transitional staging period” has the meaning given in Annex 6 to Regulation (EU) 2017/625 of the European Parliament and of the Council on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products.”

(3) In the heading of Schedule 2A, for “1 March 2022” substitute “the end of the transitional staging period”.


