The Eggs (Wales) Regulations 2022

NODYN ESBONIADOL

Mae'r Rheoliadau hyn yn diwygio'r gyfraith UE a ddargedwir sy'n sefydlu safonau marchnata ar gyfer wyau. Maent yn gymwys o ran Cymru.

Maent yn diwygio Rheoliad y Comisiwn (EC) Rhif 589/2008 (EUR 2008/589) a ddargedwir ar safonau marchnata ar gyfer wyau, drwy ganiatáu i wiriadau safonau marchnata ar wyau Dosbarth A ddigwydd mewn lleoliadau megis canolfannau pecynnau a mangroedd cyfanwerthwyr, ond cyn gwerthu i'r defnyddiwr terfynol neu i arwywyr mawr, yn hytrach na'i gwneud yn ofynnol i'r gwiriadau gael eu cynnal cyn cliriad tollau.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenheidol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend the retained EU law that establishes marketing standards for eggs. They apply in relation to Wales.

They amend retained Commission Regulation (EC) No 589/2008 (EUR 2008/589) on marketing standards for eggs, by permitting marketing standards checks on Class A eggs to take place at locations such as packing centres and wholesalers' premises, but before sale to the final consumer or to mass caterers, rather than requiring the checks to be carried out before customs clearance.

The Welsh Minister's Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely cost and benefits of complying with these Regulations.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pwerau a roddir gan adran 50(3) o Ddeddf Amaethyddiaeth 2020(1) a pharagraff 16(1) o Atodlen 5 iddi.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor sy'n gosod egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(2), ymgynghorwyd yn agored ac yn dryloyw â'r cyhoedd wrth lunio'r Rheoliadau hyn.

The Eggs (Wales) Regulations 2022

Made *2 March 2022*
Coming into force *4 March 2022*

The Welsh Ministers make these Regulations in exercise of the powers conferred by section 50(3) and paragraph 16(1) of Schedule 5 to, the Agriculture Act 2020(1).

As required by Article 9 of Regulation (EC) No 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(2) there has been open and transparent public consultation during the preparation of these Regulations.

In accordance with section 50(6)(c) of, and paragraph 16(5) of Schedule 5 to, the Agriculture Act 2020, a draft of this instrument has been laid before and approved by a resolution of Senedd Cymru.

Title, commencement and application

1.—(1) The title of these Regulations is the Eggs (Wales) Regulations 2022 and they come into force on 4 March 2022.

Diwygio Rheoliad y Comisiwn (EC) Rhif 589/2008

2.—(1) Mae Rheoliad y Comisiwn (EC) Rhif 589/2008 sy'n gosod rheolau manwl ar gyfer gweithredu Rheoliad y Cyngor (EC) Rhif 1234/2007 o ran safonau marchnata ar gyfer wyau(1) wedi ei ddiwygio yn unol â pharagraff (2).

(2) Yn Erthygl 24(3), yn yr is-baragraff cyntaf, yn lle'r geiriau o "at the time" hyd at "free circulation" rhodder "before being offered for sale to the final consumer or to mass caterers".

Amendment of Commission Regulation (EC) No 589/2008

2.—(1) Commission Regulation (EC) No 589/2008 laying down detailed rules for implementing Council Regulation (EC) No 1234/2007 as regards marketing standards for eggs(1) is amended in accordance with paragraph (2).

(2) In Article 24(3), in the first sub-paragraph, for the words from "at the time" to "free circulation" substitute "before being offered for sale to the final consumer or to mass caterers".


