Mae'r Gorchymyn hwn yn diwygio Gorchymyn Bwrdeistref Sirol Bro Morgannwg (Trefniadau Etholiadol) 2021 ("Gorchymyn 2021"), sy'n gweithredu'r argymhellion ar gyfer newidiadau i'r trefniadau etholiadol ar gyfer Bwrdeistref Sirol Bro Morgannwg, sydd wedi eu cynnwys yn adroddiad Comisiwn Ffiniau a Democratiaeth Leol Cymru, dyddiedig Chwefror 2021 ("yr Adroddiad").

Mae'r Tabl yn yr Atodlen i Orchymyn 2021 ("y Tabl") yn nodi'r trefniadau etholiadol ar gyfer Bwrdeistref Sirol Bro Morgannwg. Mae pob ward etholiadol yn cynnwys yr ardaloedd a bennir yng ngholofn (3) o'r Tabl. Drwy gamgymeriad, hepgorodd yr Adroddiad wybodaeth benodol mewn perthynas â wardiau etholiadol y Bont-faen, Dinas Powys, a Sili ac o'r herwydd nid oedd yr wybodaeth honno'n ymddangos yng ngholofn (3) o'r Tabl. Mae erthygl 2 o'r Gorchymyn hwn yn cywiro'r camgymeriad hwnnw.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal aseidiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends the County Borough of the Vale of Glamorgan (Electoral Arrangements) Order 2021 ("the 2021 Order"), which implements the recommendations for changes to the electoral arrangements for the County Borough of the Vale of Glamorgan, as contained within the report of the Local Democracy and Boundary Commission for Wales dated February 2021 ("the Report").

The Table in the Schedule to the 2021 Order ("the Table") sets out the electoral arrangements for the County Borough of the Vale of Glamorgan. Each electoral ward comprises the areas specified in column (3) of the Table. The Report mistakenly omitted certain information in relation to the electoral wards of Cowbridge, Dinas Powys, and Sully which led to that information not appearing in column (3) of the Table. Article 2 of this Order rectifies that mistake.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

Mae Gweinidogion Cymru wedi eu bodloni bod camgymeriadau wedi digwydd wrth lunio Gorchymyn Bwrdeistref Sirol Bro Morgannwg (Trefniadau Etholiadol) 2021(1) a wnaed o dan adran 37(1) o Ddeddf Llywodraeth Leol (Democratiaeth) (Cymru) 2013(2) (“Deddf 2013”).

The Welsh Ministers are satisfied that mistakes have occurred in the preparation of the County Borough of the Vale of Glamorgan (Electoral Arrangements) Order 2021(1) made under section 37(1) of the Local Government (Democracy) (Wales) Act 2013(2) (“the 2013 Act”).

Mae Gweinidogion Cymru yn ystyried ei bod yn angenrheidiol cywiro'r camgymeriadau hynny ac yn gwneud y Gorchymyn a ganlyn drwy arfer eu pŵer a roddir gan adran 43(10) o Ddeddf 2013.

The Welsh Ministers consider it necessary to rectify those mistakes and make the following Order in exercise of their power conferred by section 43(10) of the 2013 Act.

(2) Yng ngholofn (3)—

- (a) yn lle “a chymuned Pen-llin” rhodder “a chymunedau Llan-fair, a Phen-llin”;
- (b) yn lle “Cymunedau Dinas Powys, a Llanfihangel-y-pwll” rhodder “Cymunedau Dinas Powys, a Llanfihangel-y-pwll a Lecwydd”;
- (c) yn lle “Cymuned Sili” rhodder “Cymuned Sili a Larnog”.

(2) In column (3)—

- (a) for “the community of Penllyn” substitute “the communities of Llanfair, and Penllyn”;
- (b) for “The communities of Dinas Powys, and Michaelston” substitute “The communities of Dinas Powys, and Michaelston-le-Pit and Leckwith”;
- (c) for “The community of Sully” substitute “The community of Sully and Lavernock”.
