Mae'r Gorchymyn hwn yn diwygio Gorchymyn Bwrdeistref Sirol Caerffili (Trefniadau Etholiadol) 2021 ("Gorchymyn 2021"), sy'n gweithredu'r argymhellion ar gyfer newidiadau i'r trefniadau etholiadol ar gyfer Bwrdeistref Sirol Caerffili, fel yr oeddent wedi eu cynnwys yn adroddiad Comisiwn Ffiniau a Democratiaeth Leol Cymru dyddiedig mis Tachwedd 2020 ("yr Adroddiad"), gydag addasiadau.

Rhoddodd erthygl 4 o Orchymyn 2021 effaith i argymhellion y Comisiwn ar gyfer newidiadau i ffiniau wardiau cymunedol yng nghymuned Rhymni. Drwy gamgymeriad, cyfeiriodd yr Adroddiad at drosglwyddo ardal oddi wrth ward gymunedol Moriah i ward gymunedol Twyncarno pan ddylai fod wedi bod oddi wrth ward gymunedol Dewi Sant i ward gymunedol Twyncarno. Mae erthygl 2 o'r Gorchymyn hwn yn cywiro'r camgymeriad hwnnw.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Gorchymyn hwn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Gorchymyn hwn.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends the County Borough of Caerphilly (Electoral Arrangements) Order 2021 (the "2021 Order"), which implements the recommendations for changes to the electoral arrangements for the County Borough of Caerphilly, as contained within the report of the Local Democracy and Boundary Commission for Wales dated November 2020 ("the Report"), with modifications.

Article 4 of the 2021 Order gave effect to the Commission's recommendations for changes to community ward boundaries within the community of Rhymney. The Report mistakenly referred to a transfer of an area from the Moriah community ward to the Twyn Carno community ward where it should have been from the St David's community ward to the Twyn Carno community ward. Article 2 of this Order rectifies that mistake.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

Mae Gweinidogion Cymru wedi eu bodloni bod camgymeriad wedi digwydd wrth lunio Gorchymyn Bwrdeistref Sirol Caerffili (Trefniadau Etholiadol) 2021(1) a wnaed o dan adran 37(1) o Ddeddf Llywodraeth Leol (Democratiaeth) (Cymru) 2013(2) (“Deddf 2013”).

Mae Gweinidogion Cymru yn ystyried ei bod yn angenrheidiol cywiro'r camgymeriad hwnnw ac yn gwneud y Gorchymyn a ganlyn drwy arfer eu pŵer a roddir gan adran 43(10) o Ddeddf 2013.

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Bwrdeistref Sirol Caerffili (Trefniadau Etholiadol) (Diwygio) 2022.

(2) At unrhyw ddiben a nodir yn rheoliad 4(1) o Reoliadau Newidiadau i Ardaloedd Llywodraeth Leol 1976(3), daw'r Gorchymyn hwn i rym drennydd y diwrnod y'i gwneir.

*Made* 16 March 2022

*Coming into force in accordance with article 1(2) and (3)*

The Welsh Ministers are satisfied that a mistake has occurred in the preparation of the County Borough of Caerphilly (Electoral Arrangements) Order 2021(1) made under section 37(1) of the Local Government (Democracy) (Wales) Act 2013(2) (“the 2013 Act”).

The Welsh Ministers consider it necessary to rectify that mistake and make the following Order in exercise of their power conferred by section 43(10) of the 2013 Act.

**Title and commencement**

1.—(1) The title of this Order is the County Borough of Caerphilly (Electoral Arrangements) (Amendment) Order 2022.

(2) For any purpose set out in regulation 4(1) of the Local Government Area Changes Regulations 1976(3), this Order comes into force on the second day after the day on which it is made.

(3) S.I. 1976/246. Section 74(3) of the Local Government (Democracy) (Wales) Act 2013 provides that these Regulations continue to have effect in relation to orders made under Part 3 of that Act, as if those orders were made under Part 4 of the Local Government Act 1972 (c. 70) (“the 1972 Act”).

### **Diwygio Gorchymyn Bwrdeistref Sirol Caerffili (Trefniadau Etholiadol) 2021**

2.—(1) Mae Gorchymyn Bwrdeistref Sirol Caerffili (Trefniadau Etholiadol) 2021 wedi ei ddiwygio fel a ganlyn.

(2) Yn erthygl 4(b) (cymuned Rhymni: newidiadau i wardiau cymunedol), yn lle "Moriah" rhodder "Dewi Sant".

(3) For all other purposes, this Order comes into force on the ordinary day of election of councillors in 2022(1).

### **Amendment to the County Borough of Caerphilly (Electoral Arrangements) Order 2021**

2.—(1) The County Borough of Caerphilly (Electoral Arrangements) Order 2021 is amended as follows.

(2) In article 4(b) (the community of Rhymney: changes to community wards), for "Moriah" substitute "St David's".

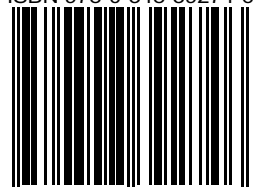
