Mae Deddf Cwricwlwm ac Asesu (Cymru) 2021 (“Deddf 2021”) yn sefydlu fframwaith cyfreithiol newydd ar gyfer cwricwlwm ac yn gwneud darpariaeth ynghylch asesu ar gyfer plant a disgyblion yng Nghymru (“y Cwricwlwm newydd i Gymru”). Mae adran 74(1) o Ddeddf 2021 yn darparu y caiff Gweinidogion Cymru wneud diwygiadau canlyniadol mewn perthynas â'r Ddeddf honno er mwyn rhoi iddi ei heffaith. Mae adran 75(1)(b) o Ddeddf 2021 yn darparu ymhellach y caiff Gweinidogion Cymru wneud darpariaeth wahanol at ddibenion gwahanol.

The Curriculum and Assessment (Wales) Act 2021 (“the 2021 Act”) establishes a new legal framework for a curriculum and makes provision about assessment for children and pupils in Wales (“the new CfW”). Section 74(1) of the 2021 Act provides that the Welsh Ministers may make consequential amendments in relation to that Act in order to give it its effect. Section 75(1)(b) of the 2021 Act further provides that the Welsh Ministers may make different provision for different purposes.

Bydd y Cwricwlwm newydd i Gymru yn cael ei gyflwyno i blant a disgyblion fesul cam. Daw'r Cwricwlwm newydd i Gymru yn fandadol ar gyfer y grwpiau blwyddyn mewn ysgolion a lleoliadau eraill fel a ganlyn—

The new CfW will be rolled out for children and pupils in a phased manner. The new CfW will become mandatory for the year groups in schools and other settings as follows—

- (a) o 1 Medi 2022 ar gyfer—
 - (i) plant y darperir addysg feithrin a gyllidir ond nas cynhelir ar eu cyfer,
 - (ii) disgyblion sy'n cael addysg feithrin mewn ysgolion a gynhelir ac ysgolion meithrin a gynhelir,
 - (iii) disgyblion yn eu blwyddyn derbyn, a
 - (iv) disgyblion ym mlynnyddoedd 1 i 6,

- (a) from 1 September 2022 for—
 - (i) children for whom funded non-maintained nursery education is provided,
 - (ii) pupils receiving nursery education at maintained schools and maintained nursery schools,
 - (iii) pupils in their reception year, and
 - (iv) pupils in years 1 to 6,

- (b) o 1 Medi 2022 ar gyfer plant a disgyblion ym mlwyddyn 7 yn yr ysgolion hynny a'r lleoliadau eraill hynny pan fo cwricwlwm wedi ei ddarparu yn unol â Deddf 2021,
- (c) o 1 Medi 2023 ar gyfer plant a disgyblion—
 - (i) ym mlwyddyn 7, a
 - (ii) ym mlwyddyn 8,
- (d) o 1 Medi 2024 ar gyfer plant a disgyblion ym mlwyddyn 9,
- (e) o 1 Medi 2025 ar gyfer plant a disgyblion ym mlwyddyn 10, ac
- (f) o 1 Medi 2026 ar gyfer plant a disgyblion ym mlynnyddoedd 11 i 13.

Mae'r Rheoliadau hyn yn gymwys mewn perthynas â phlant a disgyblion y darperir addysg iddynt—

- (a) mewn ysgolion a gynhelir,
- (b) mewn ysgolion meithrin a gynhelir,
- (c) gan ddarparwyr addysg feithrin a gyllidir ond nas cynhelir,
- (d) mewn unedau cyfeirio disgyblion, ac
- (e) gan bersonau sy'n darparu addysgu a dysgu ar gyfer plentyn ac eithrio mewn ysgol a gynhelir, ysgol feithrin a gynhelir neu uned cyfeirio disgyblion yn rhinwedd trefniadau a wneir o dan adran 19A o Ddeddf Addysg 1996.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

- (b) from 1 September 2022 for children and pupils in year 7 in those schools and other settings where there is a curriculum provided in accordance with the 2021 Act,
- (c) from 1 September 2023 for children and pupils—
 - (i) in year 7, and
 - (ii) in year 8,
- (d) from 1 September 2024 for children and pupils in year 9,
- (e) from 1 September 2025 for children and pupils in year 10, and
- (f) from 1 September 2026 for children and pupils in years 11 to 13.

These Regulations apply in relation to children and pupils to whom education is provided—

- (a) in maintained schools,
- (b) in maintained nursery schools,
- (c) by funded non-maintained nursery education providers,
- (d) in pupil referral units, and
- (e) by persons who provide teaching and learning for a child otherwise than at a maintained school, maintained nursery school or pupil referral unit by virtue of arrangements made under section 19A of the Education Act 1996.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Title and commencement

1.—(1) Enw'r Rheoliadau hyn yw Rheoliadau Deddf Cwricwlwm ac Asesu (Cymru) 2021 (Diwygiadau Canlyniadol) (Is-ddeddfwriaeth) (Rhif 1) 2022.

1.—(1) The title of these Regulations is the Curriculum and Assessment (Wales) Act 2021 (Consequential Amendments) (Secondary Legislation) (No. 1) Regulations 2022.

“nursery education” (“*addysg feithrin*”) means education provided to children or pupils below compulsory school age—

(a) in a maintained school or a maintained nursery school, or

(b) by the provider of funded non-maintained nursery education;

“pupil” (“*disgybl*”) has the meaning given to it in section 3 of the Education Act 1996(1);

“reception year” (“*blwyddyn derbyn*”) means a year group in which the majority of the pupils attain the age of 5;

“relevant curriculum” (“*cwricwlwm perthnasol*”) has the meaning given to it in section 56(5) of the 2021 Act;

“year 1” (“*blwyddyn 1*”) means the year group in which the majority of pupils attain the age of 6;

“year 2” (“*blwyddyn 2*”) means the year group in which the majority of pupils attain the age of 7;

“year 3” (“*blwyddyn 3*”) means the year group in which the majority of pupils attain the age of 8;

“year 4” (“*blwyddyn 4*”) means the year group in which the majority of pupils attain the age of 9;

“year 5” (“*blwyddyn 5*”) means the year group in which the majority of pupils attain the age of 10;

“year 6” (“*blwyddyn 6*”) means the year group in which the majority of pupils attain the age of 11;

Education (Maintained Special Schools) (Wales) Regulations 1999

3.—(1) The Education (Maintained Special Schools) (Wales) Regulations 1999(1) are amended as follows.

 - (i) in years 1 to 6;
 - (ii) in year 7 in those schools and other settings where the head teacher and governing body have adopted a relevant curriculum under Part 2 of the 2021 Act;
- (b) from 1 September 2023 are—
 - (i) in year 7;
 - (ii) in year 8;
- (c) from 1 September 2024 are in year 9;
- (d) from 1 September 2025 are in year 10;
- (e) from 1 September 2026 are in years 11 to 13.

(3) In regulation 12(2)—

- (a) for the heading “Religious Education” substitute “Religious Worship”, and
- (b) omit paragraph (a) and the “and” after it.

Education (Aptitude for Particular Subjects) Regulations 1999

4.—(1) The Education (Aptitude for Particular Subjects) Regulations 1999(1) are amended as follows.

 - (ii) in years 1 to 6 at a maintained school;
