Mae Deddf Addysg (Cymru) 2014 (“Deddf 2014”) yn gwneud darpariaeth mewn perthynas â Chyngor y Gweithlu Addysg (“y Cyngor”). Mae Rhan 2 o Ddeddf 2014 yn rhoi swyddogaethau i'r Cyngor mewn perthynas â phersonau y mae'n ofynnol iddynt gofrestru yn y gofrestr y mae'r Cyngor yn ei chynnal yn unol ag adran 9 o'r Ddeddf honno (“y Gofrestr”).

The Education (Wales) Act 2014 (“the 2014 Act”) makes provision in relation to the Education Workforce Council (“the Council”). Part 2 of the 2014 Act confers functions on the Council in relation to persons who are required to register in the register the Council maintains in accordance with section 9 of that Act (“the Register”).

Mae'r categorïau o bersonau cofrestredig wedi eu nodi yn Nhabl 1 ym mharagraff 1 yn Atodlen 2 i Ddeddf 2014. Mae gan Weinidogion Cymru y pŵer ym mharagraff 2 o'r Atodlen honno i ychwanegu, diwygio neu ddileu categori cofrestru. Yn unol â hynny, mae Rhan 6 o'r Gorchymyn hwn yn diwygio Tabl 1 ym mharagraff 1 yn Atodlen 2 i Ddeddf 2014 er mwyn ychwanegu'r categorïau a ganlyn o bersonau cofrestredig—

The categories of registered persons are set out in Table 1 in paragraph 1 in Schedule 2 to the 2014 Act. The Welsh Ministers have the power in paragraph 2 of that Schedule to add, amend or remove a category of registration. Accordingly, Part 6 of this Order amends Table 1 in paragraph 1 in Schedule 2 to the 2014 Act to add the following categories of registered person—

- (a) athro neu athrawes ysgol annibynnol,
- (b) gweithiwr cymorth dysgu mewn ysgol annibynnol,
- (c) athro neu athrawes sefydliad ôl-16 arbennig annibynnol, a
- (d) gweithiwr cymorth dysgu mewn sefydliad ôl-16 arbennig annibynnol.

- (a) independent school teacher,
- (b) independent school learning support worker,
- (c) independent special post-16 institution teacher, and
- (d) independent special post-16 institution learning support worker.

Mae Rhan 2 o'r Gorchymyn hwn yn pennu gwasanaethau athro neu athrawes ysgol annibynnol. Ni chaniateir i'r gwasanaethau hyn gael eu darparu mewn neu ar ran ysgolion annibynnol ond gan bersonau sydd wedi eu cofrestru â'r Cyngor yn y categori athro neu athrawes ysgol annibynnol. Mae'r Rhan hon hefyd yn

Part 2 of this Order specifies independent school teacher services. These services may only be provided in or for independent schools by persons who are registered with the Council in the category of independent school teacher. This Part also provides that only persons registered in the category of

Mae'r Rhan hon hefyd yn darparu mai dim ond personau sydd wedi eu cofrestru yn y categori gweithiwr cymorth dysgu mewn sefydliad ôl-16 arbennig annibynnol a gaiff gefnogi'r gwaith o ddarparu gwasanaethau athro neu athrawes sefydliad ôl-16 arbennig annibynnol mewn neu ar ran sefydliad ôl-16 arbennig annibynnol. Fodd bynnag, nid yw'r gofynion i gofrestru a nodir yn y Rhan hon yn gymwys i bersonau sy'n darparu'r gwasanaethau neu'n cefnogi'r gwaith o ddarparu gwasanaethau fel gwirfoddolwyr.

Mae Rhan 4 o'r Gorchymyn hwn yn gwneud diwygiadau i Orchymyn Cyngor y Gweithlu Addysg (Cofrestru Gweithwyr Ieuencid, Gweithwyr Cymorth Ieuencid ac Ymarferwyr Dysgu Seiliedig ar Waith) 2016 ("Gorchymyn 2016"). Rhoddir cyfeiriadau at "cyflogwr perthnasol" yn lle cyfeiriadau at "corff perthnasol" yng Ngorchymyn 2016. Ystyr cyflogwr perthnasol yw person sy'n cyflogi neu fel arall yn cymryd ymlaen bersonau i ddarparu gwasanaethau datblygu ieuencid yng Nghymru.

Mae'r Rhan hon hefyd yn darparu bod person yn gymwys i gofrestru dros dro fel gweithiwr ieuencid os yw'n gweithio tuag at ennill cymhwyster gweithiwr ieuencid. Hefyd, mae person yn gymwys i gofrestru dros dro fel gweithiwr cymorth ieuencid os yw'n gweithio tuag at ennill cymhwyster gweithiwr cymorth ieuencid. Rhaid i berson sy'n gymwys i gofrestru dros dro fod yn gofrestredig dros dro er mwyn darparu gwasanaethau datblygu ieuencid ar gyfer neu ar ran cyflogwr perthnasol (oni bai ei fod yn darparu'r gwasanaethau fel gwirfoddolwr).

Mae'r Rhan hon hefyd yn gosod dyletswyddau ar y Cyngor i lunio a chynnal rhestr o gymwysterau gweithwyr ieuencid a chymwysterau gweithwyr cymorth ieuencid. Rhaid i'r Cyngor hysbysu Gweinidogion Cymru, yn flynyddol, am unrhyw ddiwygiadau y dylid eu gwneud i'r rhestr o gymwysterau gweithwyr ieuencid a'r rhestr o gymwysterau gweithwyr cymorth ieuencid fel y'u nodir yn Atodlenni 1 a 2 i Orchymyn 2016.

independent school learning support worker may support the provision of independent school teacher services in or for an independent school. However, the requirements to register set out in this Part do not apply to persons who provide the services or support the provision of services as volunteers.

Part 3 of this Order specifies independent special post-16 institution teacher services. These services may only be provided in or for an independent special post-16 institution by persons who are registered with the Council in the category of independent special post-16 institution teacher. This Part also provides that only persons registered in the category of independent special post-16 institution learning support worker may support the provision of independent special post-16 institution teacher services in or for an independent special post-16 institution. However, the requirements to register set out in this Part do not apply to persons who provide the services or support the provision of services as volunteers.

Part 4 of this Order makes amendments to the Education Workforce Council (Registration of Youth Workers, Youth Support Workers and Work Based Learning Practitioners) Order 2016 ("the 2016 Order"). References in the 2016 Order to "relevant body" are replaced with references to "relevant employer". A relevant employer means a person who employs or otherwise engages persons to provide youth development services in Wales.

This Part also provides that a person is eligible for provisional registration as a youth worker if they are working towards obtaining a youth worker qualification. Also, a person is eligible for provisional registration as a youth support worker if they are working towards obtaining a youth support worker qualification. A person who is eligible for provisional registration must be provisionally registered in order to provide youth development services for or on behalf of a relevant employer (unless they are providing the services as a volunteer).

This Part also imposes duties on the Council to prepare and maintain a list of youth worker qualifications and youth support worker qualifications. The Council must inform the Welsh Ministers, on an annual basis, of any amendments that should be made to the list of youth worker and list of youth support worker qualifications as set out in Schedules 1 and 2 to the 2016 Order.

Mae’r diffiniad o “gwaith penodedig” yn rheoliad 17 o Reoliadau 2015 wedi ei ddiwygio er mwyn gwneud yn siŵr bod pob athro neu athrawes sy’n bennaeth neu sydd â rôl arall fel uwch-arweinydd yn cael ei gwmpasu neu ei chwmpasu yn y categori athro neu athrawes ysgol. Mae’r diwygiadau hefyd yn symleiddio’r gofynion mewn perthynas â gweithwyr cymorth dysgu mewn ysgolion ac yn ei gwneud yn glir nad oes rhaid i athro neu athrawes ysgol gofrestru yn y categori gweithiwr cymorth dysgu hefyd oni bai bod y person hwnnw wedi ei gyflogi neu wedi ei gymryd ymlaen fel arall fel gweithiwr cymorth dysgu mewn ysgol yng Nghymru. Mae’r diwygiadau yn diwygio’r gofynion mewn perthynas â gweithwyr cymorth dysgu mewn addysg bellach i’w gwneud yn glir nad oes rhaid i athro neu athrawes addysg bellach gofrestru yn y categori gweithiwr cymorth dysgu mewn addysg bellach hefyd oni bai bod y person hwnnw wedi ei gyflogi neu wedi ei gymryd ymlaen fel arall fel gweithiwr cymorth dysgu mewn addysg bellach mewn sefydliad addysg bellach yng Nghymru.

Mae Rhan 7 o’r Gorchymyn hwn yn diwygio Rheoliadau Cyngor y Gweithlu Addysg (Ffioedd Cofrestru) 2017 (“Rheoliadau 2017”) er mwyn gwneud darpariaeth mewn perthynas â swm y ffi gofrestru sy’n daladwy gan y categorïau cofrestru newydd. Mae’r ffioedd sy’n daladwy ar gyfer pob categori cofrestru wedi eu nodi yn rheoliad 4 o Reoliadau 2017. Mae rheoliad 4 hefyd yn darparu y caiff Gweinidogion Cymru benderfynu swm y cymhorthdal a roddir tuag at y ffioedd cofrestru hynny ac yn ei gwneud yn ofynnol iddynt gyhoeddi swm y cymhorthdal hwnnw ar wefan Llywodraeth Cymru.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Aseidiadau Effaith Rheoleiddiol mewn perthynas â’r Rheoliadau hyn. O ganlyniad, lluniwyd aseiad effaith rheoleiddiol o’r costau a’r manteision sy’n debygol o ddeillio o gydymffurfio â’r Rheoliadau hyn. Part 5 makes amendments to the Education Workforce Council (Main Functions) (Wales) Regulations 2015 (“the 2015 Regulations”) in relation to school teachers and learning support workers. The definition of “specified work” in regulation 17 of the 2015 Regulations is amended to make sure all teachers who are head teachers or have another senior leadership role are captured in the category of school teacher. The amendments also simplify the requirements in relation to school learning support workers and make clear that a school teacher does not also have to register in the category of learning support worker unless that person is employed or otherwise engaged as a school learning support worker in a school in Wales. The amendments amend the requirements in relation to further education learning support workers to make clear that a further education teacher does not also have to register in the category of further education learning support worker unless that person is employed or otherwise engaged as a further education learning support worker in a further education institution in Wales.

Part 7 of this Order amends the Education Workforce Council (Registration Fees) Regulations 2017 (“the 2017 Regulations”) to make provision in relation to the amount of registration fee payable by the new categories of registration. The fees payable for all categories of registration are set out in regulation 4 of the 2017 Regulations. Regulation 4 also provides that the Welsh Ministers may determine the amount by which those registration fees will be subsidised and requires them to publish the amount of that subsidy on the Welsh Government website.

The Welsh Ministers’ Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. Title and commencement

PART 2

INDEPENDENT SCHOOLS

Independent school teacher services

3.—(1) Each of the following activities are independent school teacher services for the purposes of this Part—

- (a) planning and preparing lessons and courses for pupils;
- (b) delivering lessons to pupils;
- (c) assessing the development, progress and attainment of pupils;
- (d) reporting on the development, progress and attainment of pupils;
