The A483 Trunk Road (Rhosmaen
Street, Llandeilo, Carmarthenshire)
(Temporary Prohibition of Vehicles)
Order 2023

Made 6 July 2023

Coming into force 8 July 2023

The Welsh Ministers, as traffic authority for the relevant length of the A483 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited by reason of a relevant event, namely the Llandeilo Pride March, being held on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A483 Trunk Road (Rhosmaen Street, Llandeilo, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2023 and this Order comes into force on 8 July 2023.

Interpretation

2. In this Order—

“event period” (“*cyfnod y digwyddiad*”) means that period commencing at 12:30 hours on 8 July 2023 and ending when the temporary traffic signs are permanently removed;

“exempted vehicle” (“*cerbyd esempt*”) means—

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

- (i) any vehicle being used for police, fire or ambulance services purposes;
- (ii) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;
- (iii) any vehicle used by an authorised event official in support of and for reasons of the safety of the event;

“the trunk road” (“y *gefnffordd*”) means the A483 Swansea to Manchester trunk road.

Prohibition

3. No person may, during the event period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road known as Rhosmaen Street, Llandeilo that extends from its junction with Crescent Road to its junction with King Street.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 1 day.
