SCHEDULE 2

CONSEQUENTIAL AMENDMENTS

Landlord and Tenant Act 1985

16.—(1) The Landlord and Tenant Act 1985⁽¹⁾ is amended as follows.

(2) In section 14(4)⁽⁴⁾ (repairing obligations in leases: exceptions), for “registered housing association” substitute “registered social landlord”.

(3) In section 26(3)(a)⁽²⁾ (exceptions to service charge controls &c.: meaning of long tenancy), for “registered” substitute “a registered social landlord”.

(4) In section 38⁽³⁾ (minor definitions), for the definition of “registered” substitute—
““registered social landlord” has the same meaning as in the Housing Act 1985 (see section 5(4) and (5) of that Act);”

(5) In section 39 (index of defined expressions), for “registered (in relation to a housing association)” substitute “registered social landlord”.
