Saving Provisions) (Amendment) Order 2021.

The Welsh Ministers, in exercise of the powers conferred by section 100(3) and (4) of the Additional Learning Needs and Education Tribunal (Wales) Act 2018(1), make the following Order:

Title

1. The title of this Order is the Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Amendment of Commencement Order No. 2 and Revocation of Commencement Order No. 3 and Commencement Order No. 4) Order 2021.

Amendment of the Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Commencement No. 2) Order 2021

2.—(1) The Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Commencement No. 2) Order 2021(2) is amended as follows.

(2) In article 1(2), insert in the appropriate place—

(1) 2018 dccc 2.

“ystyr “blwyddyn 11” (“year 11”) yw grŵp blwyddyn y bydd mwyafrif y plant, yn ystod y flwyddyn ysgol, yn cyrraedd 16 oed;”

“mae i “blwyddyn ysgol” yr un ystyr â “school year” yn adran 579(1) o Ddeddf 1996;”

“ystyr “grŵp blwyddyn” (“year group”) yw grŵp o blant mewn ysgol y bydd y mwyafrif ohonynt, mewn blwyddyn ysgol benodol, yn cyrraedd yr un oedran;”.

(3) Yn erthygl 4, o flaen paragraff (a) mewnosoder—

“(za) sydd ym mlwyddyn 11;

(zb) nad yw mewn ysgol ac a fydd yn cyrraedd 16 oed yn ystod y flwyddyn ysgol 2021-2022;”.

(4) Yn erthygl 6, ar ôl “o fewn” mewnosoder “y naill neu’r llall o’r paragraffau yn”.

(5) Yn lle erthygl 7 rhodder—

“7. Person y mae cynllun datblygu unigol—

(a) yn cael ei lunio o dan adran 40 neu ei gadw o dan adran 42 o’r Ddeddf mewn perthynas ag ef;

(b) yn cael ei lunio neu ei gynnal o dan adran 14 o’r Ddeddf o ganlyniad i reoliad 23 o Reoliadau Anghenion Dysgu Ychwanegol (Cymru) 2021(2).”

““school year” (“blwyddyn ysgol”) has the same meaning as in section 579(1) of the 1996 Act;”

““year 11” (“blwyddyn 11”) means a year group in which the majority of children will, in the school year, attain the age of 16;”

““year group” (“grŵp blwyddyn”) means a group of children at a school the majority of whom will, in a particular school year, attain the same age”.

(3) In article 4, before paragraph (a) insert—

“(za) who is in year 11;

(zb) who is not at a school and will attain the age of 16 during the 2021-2022 school year;”.

(4) In article 6, after “falls into” insert “either of the paragraphs in”.

(5) For article 7 substitute—

“7. A person in relation to whom an individual development plan —

(a) is being prepared under section 40 or kept under section 42 of the Act;

(b) is being prepared or maintained under section 14 of the Act as a result of regulation 23 of the Additional Learning Needs (Wales) Regulations 2021(2).”

3. The Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Commencement No. 3 and Transitional and Saving Provisions) Order 2021(3) is revoked.

4. The Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Commencement No. 4 and Transitional and Saving Provisions) Order 2021(4) is revoked.

5. The Additional Learning Needs and Education Tribunal (Wales) Act 2018 (Commencement No. 3 and No. 4 and Transitional and Saving Provisions) (Amendment) Order 2021(5) is revoked.
